

**PUBLIC LANDS ACT**

BEING CHAPTER P-40 R.S.A. 2000 (the "Act")

**ENFORCEMENT ORDER NO. PLA-EO-2017/02-LAR**

WHEREAS the land that is further described as NE Section 34, Township 62, Range 07, West of the 4<sup>th</sup> Meridian near Bonnyville, in the Province of Alberta [the "Crown Lands"] are "public lands" within the meaning of section 1(p) of the *Public Lands Act*;

WHEREAS section 54 (1) (a.1) of the *Public Lands Act* states that no person shall cause, permit, or suffer the loss or damage to public land;

WHEREAS on April 5, 2017 Alberta Environment and Parks received a report indicating a motor vehicle had been observed causing damage to the Crown Lands;

WHEREAS on April 6, 2017 Alberta Environment and Parks staff received photographic, video, and documentary evidence indicating the damages to the Crown Lands were caused by MURRAY.

WHEREAS Alberta Environment and Parks has never authorized MURRAY to cause damage to the Crown Lands for any purpose;

WHEREAS MURRAY has unlawfully caused damage to the Crown Lands;

WHEREAS section 59.1 (1) of the *Public Lands Act* provides that where a person has contravened a section of the *Public Lands Act*, the Director may issue an enforcement order to the person;

WHEREAS Neil Brad, Regional Compliance Manager, Lower Athabasca Region, Alberta Environment and Parks, has been designated as a director under the *Public Lands Act* for the purposes of issuing enforcement orders (the "Director");

THEREFORE, I, Neil Brad, the Director, pursuant to section 59.1 of the *Public Lands Act*, DO HEREBY ORDER THAT:

1. MURRAY shall submit to Alberta Environment and Parks, by no later than May 3, 2017 a written remediation plan for the Crown Lands including the following:

- a. A description of the method that will be used to remove rutting from the surface of the Crown Lands as identified in Schedule 1:
  - b. A description of the methods that will be used to install one sign post and sign (to be provided to MURRAY by Alberta Environment and Parks) at the trailhead to the Crown Lands.
2. MURRAY shall complete remedial works on Crown Lands in accordance with the written plan by no later than May 17, 2017.
3. MURRAY shall provide written notice to Alberta Environment and Parks of the completion of the aforementioned by no later than May 23, 2017.

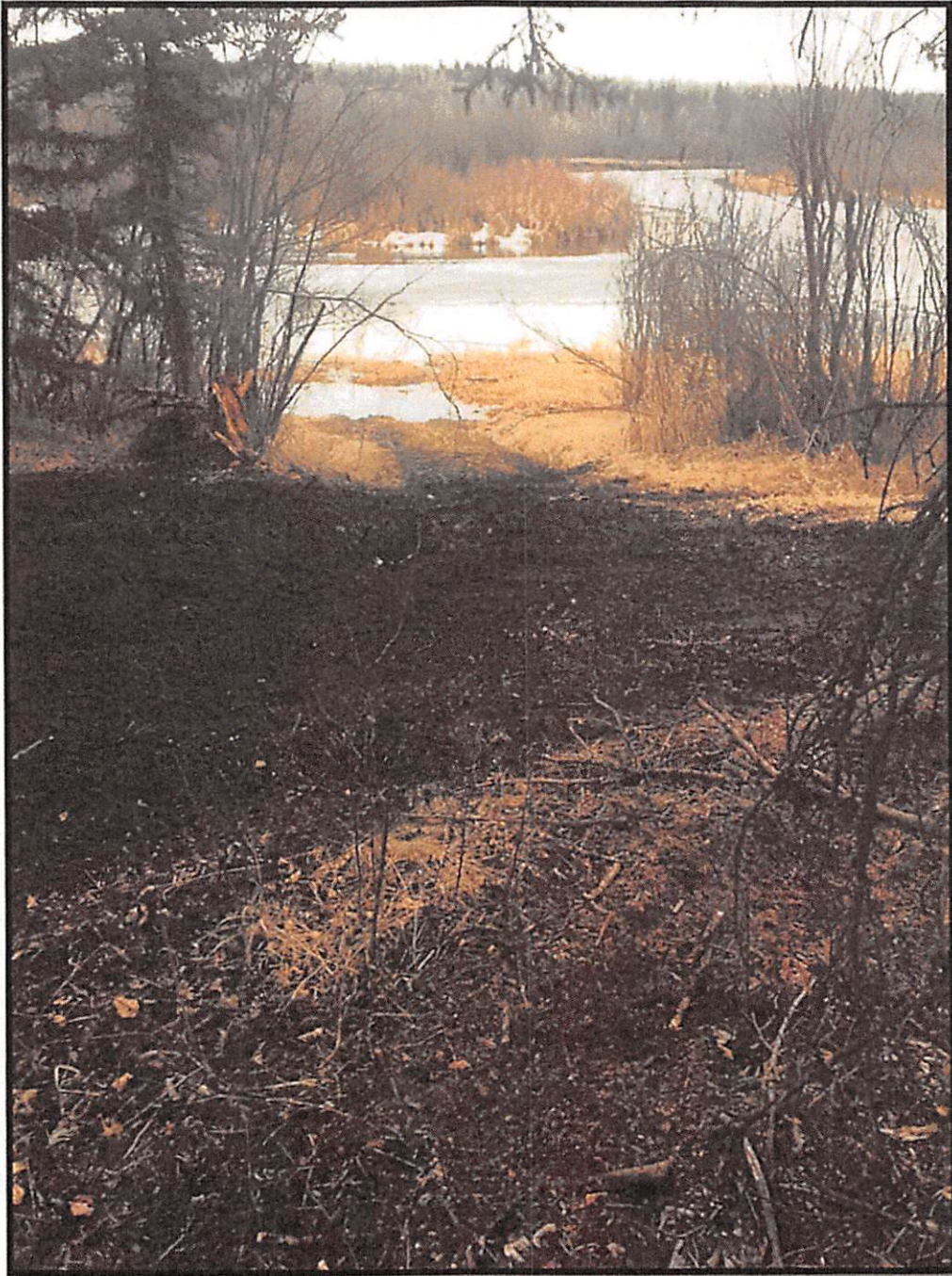

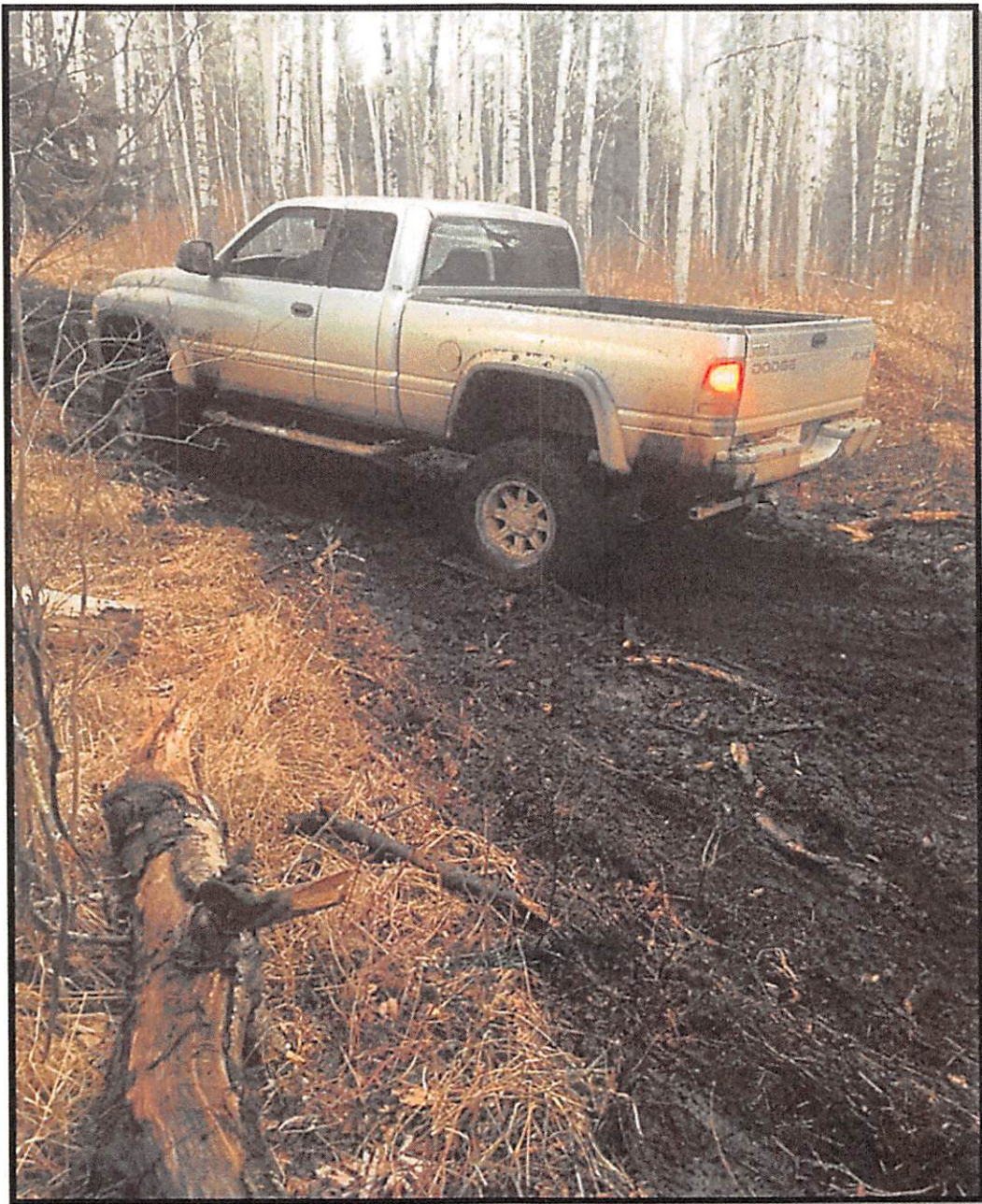
