### Re: Integration of SFMP 2005 into the DFMP 2003

In November 2003, Sustainable Resource Development approved the Canadian Forest Products Ltd. (Canfor) Detailed Forest Management Plan (DFMP 2003). The plan contained the Sustainable Forest Management Plan (SFMP 2001), which was certified to the CAN/CSA Z809-96 standard. In July 2005, Canfor prepared a 'new' SFMP to the CAN/CSA-Z809-02 standard and, after review by a third party auditor, it was certified on November 7, 2005. Canfor's Forest Management Advisory Committee played an important role in development of the SFMP 2005 by identifying locally relevant values, goals, indicators and targets. It is Canfor's objective to integrate the SFMP 2005 into the approved Detailed Forest Management Plan and to receive approval from your office regarding our process. To facilitate that objective, please find enclosed three documents:

- SFMP 2005 (certified to CAN/CSA-Z809-02);
- DFMP 2003/ SFMP 2005 Integration Matrix; and
- ◆ DFMP 2003/ SFMP 2005 Cross Reference Table.

The Integration Matrix provides the indicators and objectives that are contained in the approved DFMP 2003 and, via a side-by-side comparison, directly links them to the indicators and targets from the SFMP 2005. Canfor will monitor these 'new' indicators and report the results in its *Annual Performance Monitoring Report*.

The Cross Reference Table (CRT) can be used as a reference tool when reading the DFMP 2003 text. For example, if Objective 1.1a.1 is referenced in the DFMP, then from line 1 of the CRT, the reader would see that the corresponding target in the SFMP 2005 would be Target (1.4) 1a.2.1.
