On February 23, 2017, Adrian Lepine was found hanging in the basement of his home.

EISEL, Trevor Clinton, 33, Stony Plain

On December 25, 2017, Trevor Eisel took his own life following a prolonged standoff with police.

CREEDGEUR, Kaitlind Ann-Louise, Edmonton

On June 22, 2018, Kaitlind Credgeur was found unresponsive in her bed at Alberta Hospital Edmonton.

HEYDENRYCH, Siegfriedt Louw, 52, Cold Lake

On May 27, 2018, Siegfriedt Heydenrych was found unresponsive in his hospital bed.

ROGG, Justin, 30, Edmonton

On August 30, 2016, Justin Rogg was found hanging in a University of Alberta building.

ALLINSON, Jason, 45, Edmonton

On December 24, 2018, Jason Allinson died from smoke inhalation during a house fire in his residence.

BELOIN, Bill, 38, Edmonton

On December 24, 2018, Bill Beloin died from smoke inhalation during a house fire in his residence.

NONAME, Deanna, 55, Edmonton

On August 7, 2017, Deanna Noname died after suffering a stroke while in the custody of police.

On September 18, 2014, S.R. was taken to the Ponoka Hospital with a closed head injury. She was later transferred to the Stollery Children's Hospital where she succumbed to her injuries on September 27, 2014.

HILL, Katherine Helena, 92, Calgary

On November 15, 2016, Katherine Hill died in hospital from complications of a blunt head injury.

NOERING, Tyshawn, 24, Edmonton

On April 10, 2019, Tyshawn Noering was found unresponsive in his cell at the Edmonton Remand Centre.

E.R.

On March 29, 2017, E.R. was found deceased in bed with her mother. The cause of death was determined to be methamphetamine toxicity.

ROGERS, Richard, 54, Fort McMurray

On September 24, 2014, Richard Rogers received a fatal chest injury when a large air conditioning unit fell on him.

On May 27, 2019, Amara Rose Meyer was trapped inside a clothing donation bin, and died.

O'QUINN, Jessey Neil, 24, Calgary

On July 20, 2017, Jessey Neil O'Quinn was trapped inside a clothing donation bin, and died.

On May 25, 2019, Michael Robert Mullock had been taken into custody by the Airdrie RCMP detachment and was found, several hours later, unresponsive in the cell.

On May 7, 2019, Gregory Glaicar was working near a silo filled with sand when it collapsed. He was buried under the sand and debris.

KRICK, Shane, 43, Smithers

On May 7, 2019, Shane Krick was working near a silo filled with sand when it collapsed. He was buried under the sand and debris.

ALO, Bolanle Idowu, 49, Calgary

On August 7, 2018, Bolanle Alo collapsed suddenly during a struggle. He was in the process of being deported.

BRANCONNIER, Kyle Nelson 32, Edmonton

On June 8, 2020, Kyle Branconnier suffered a medical episode at his group home. He was taken to hospital, and died on June 11, 2020.

On May 17, 2018, Josephine Pelletier was involved in an altercation with police. Resuscitation was provided, but she died at the scene.

ROBERTSON, Frederick David, 40, Calgary

On January 28, 2021, Frederick Robertson was found unresponsive in his cell at the Calgary Remand Centre.

On July 7, 2016, P.J.P. died following head trauma sustained on July 5, 2016.

BRYCE, Caleb, 23, Calgary

On September 29, 2020, Caleb Bryce was driving a motorcycle and was involved in a collision with another vehicle at an intersection and died.

LINDAL, Finley, 18, Edmonton

On December 1, 2020, Finley Lindal was found unresponsive in his bedroom.

On June 26, 2021, J.N. was found unresponsive. He was taken to hospital, but died despite emergency medical intervention.

CALLIOUX, Ashton, 23, Edmonton

On July 29, 2021, Ashton Callioux was found by police in the basement of an empty house. He became unresponsive. Emergency personnel attended, but attempts to resuscitate him were unsuccessful.

On June 5, 2021, Edward McClennon was admitted to hospital from remand jail with possible opioid withdrawal symptoms. He died on June 8, 2021 after suffering a seizure.
