## OIL SANDS INFORMATION BULLETIN 2024-01

### Subject: Publication of 2023 Royalty Project Data and Exemption Criteria

The 2023 oil sands royalty project data will be published on the Alberta Royalty Framework website (<https://www.alberta.ca/royalty-oil-sands-project-data.aspx>) as well as the oil sands royalty projects map (<https://gis.energy.gov.ab.ca/geoview/Royalty>) in August 2024.

The project data is based on information provided by industry operators in the 2023 End of Period Statements (EOPS) and any subsequent amendments submitted to Alberta Energy and Minerals as of May 8, 2024. The 2019, 2020, 2021, 2022 and 2023 data will remain viewable via a downloadable excel file located on the open data section of the website (<https://open.alberta.ca/opendata/alberta-oil-sands-royalty-data1>). Additionally, the 2019, 2020, 2021 and 2022 data will be updated to incorporate any changes since the last publication.

For situations where a company (corporate-wide) has fewer than three unique purchasers of bitumen throughout the year or fewer than three unique diluent suppliers throughout the year, both the 2023 project revenue and diluent cost data categories may be exempted from publication for three years. This exemption will not be applicable to projects that are subject to the Bitumen Valuation Methodology. To be eligible for a three year exemption, companies meeting the criteria must complete and submit the attached form – *Request for Three Year Exemption from Publication of 2023 Project Revenue and Diluent Cost* to Narisa Azim at [Narisa.Azim@gov.ab.ca](mailto:Narisa.Azim@gov.ab.ca) by July 26, 2024

Note that exemptions must be applied for annually. Even if exemptions were granted for the previous years' royalty project data, a new application for the current year's data must be submitted and approved, otherwise project revenue and diluent cost data will be published.

All other data fields will be published without delay.
