Re: **General Rates of Timber February 2014**

This letter is notice of Crown Timber and Forest Resource Improvement Association of Alberta (FRIAA) dues for timber that is used or will be used to make lumber, pulp or roundwood timber products as established in the *Timber Management Regulation* and the *Forest Resources Improvement Regulation*. Please submit your timber returns for the period February 1 to February 28, 2014 using the following rates:

The **Crown Timber Dues** are payable to the **Government of Alberta**. Please be sure only to pay the net timber dues to the Government of Alberta. For the month of February 2014, these net timber dues are **\$3.15** per cubic meter for sales under 107 296 m³ and **\$4.76** per cubic meter for sales over 107 296 m³. These payments may be made by sending your cheque and timber return to:
