Custom Compression Garments

Procedure

Custom compression garment manufacturers must meet the following criteria to provide custom compression garments through the Alberta Aids to Daily Living (AADL) program:

- provide a measuring manual and measuring charts/forms
- have a warranty on fit (minimum 10 days from receipt of delivery) and a warranty on stated compression for six months duration
- be accessible by phone to authorizers for issues/problem solving
- have a method in place to ensure materials provide stated compression
- participate in accreditation process

When upgrading to garments with straps, clients are responsible for paying the upgrade charges and may choose products from the following manufacturer brands:
