WHEREAS Enforcement Order No. WA-EO-2012/05-CR [the "EO"] was issued to the Parties on June 27, 2012;

WHEREAS the EO required the Methots to complete the work required under the EO by August 31, 2012;

WHEREAS since the EO was issued, the Methots have submitted and the Director has approved the Remedial Plan required under the EO, however to implement the approved Remedial Plan, the Methots require an authorization under the *Public Lands Act*;

WHEREAS the extra time involved in obtaining the prerequisite *Public Lands Act* authorization means that the Methots required an extension to the August 31, 2012 deadline to complete the work under the approved Remedial Plan;

WHEREAS Amendment #1 to the EO was issued on August 30, 2012 changing the deadline to complete the work under the approved Remedial Plan from August 31, 2012 to October 1, 2012;

WHEREAS there has been an unexpected delay in the Methots obtaining the prerequisite authorization under the *Public Lands Act*, resulting in the Methots requiring more time to complete the work under the approved Remedial Plan;

WHEREAS Faye Hutchings, Acting District Compliance Manager, Central Region, has been appointed a Director for the purposes of issuing and amending enforcement orders under the Act (the "Director");

THEREFORE, I, Faye Hutchings, Acting District Compliance Manager, Central Region, pursuant to section 137 of the *Water Act*, DO HEREBY AMEND THE EO and AMENDMENT #1 to the EO and ORDER:

1. In Clause 1 (page 2) of Amendment #1 to Enforcement Order No. WA-EO-2012/05-CR, the date of "**October 1, 2012**" is deleted and "**December 14, 2012**" is inserted in its place.
