BRONAUGH, Michael Benjamin, 24, Edmonton

On December 11, 2011, Michael Bronaugh was shot by police during an armed bank robbery. He was transported to hospital where he died on December 12, 2011.

GOLTMAN, Lisa Rachel, 22, Edmonton

On May 4, 2013, Lisa Goltman was found unresponsive in her bed at Alberta Hospital Edmonton.

HOLTEEN, Ryan, 32, Edmonton

On September 26, 2013, Ryan Holteen was found unresponsive in his cell at the Edmonton Institution. Four other inmates have been criminally charged in relation to his death.

CHARLAND, Daniel, 52, Cold Lake

On August 15, 2013, Daniel Charland was shot during an altercation with the Cold Lake RCMP.

MATTHON, Shane, 31, Edmonton

On March 7, 2015, Shane Matthon was found collapsed at the Fort Saskatchewan Correctional Centre where he was serving a conditional sentence on weekends.

OLENYK, Timothy James, 18, Cochrane

On July 10, 2015, Timothy Olenyk died after jumping from a parking garage.

WITVOET, Ryan William, 31, Edmonton

On August 20, 2015, Ryan Witvoet was found in asystolic arrest in the Edmonton Institution. He was transported to hospital where it he was pronounced dead.

SINCLAIR, Jason, 29, Edmonton

On September 27, 2015, Jason Sinclair was involved in an altercation with his cellmate at the Edmonton Remand Centre. He was restrained and taken to a decontamination area where he went into medical distress. Resuscitative efforts began and he was transported to hospital where his condition deteriorated and he was pronounced dead on September 29, 2015.

ROACH, Patricia, 54, Edmonton

GEARHART, John, 37, Edmonton

On October 24, 2015, Patricia Roach was found restrained and deceased in her home.

On October 22, 2015, John Gearhart took his own life by driving in front of a moving locomotive.

SIMON, Cheryl Wendy, 42, Red Deer

On April 11, 2014, Cheryl Simon was arrested by the Hobbema RCMP and put in a holding cell. She was found unresponsive early the next morning. Resuscitation was started and she was transported to hospital where she died on April 15, 2014.

SCHOCK, Chantel Leanne, 35, Edmonton

On March 9, 2016, Chantel Schock was found unresponsive in the emergency department of the Misericordia Hospital.

WYNN, Cst. David Matthew, 42, St. Albert

REHN, Shawn Maxwell, 34, Spruce Grove

In the early morning hours of January 17, 2015, Cst. David Wynn of the RCMP was investigating a stolen vehicle when he identified Shawn Rehn as a suspect. Cst. Wynn received a gunshot wound from Rehn and died in hospital on January 21, 2015.

Shawn Rehn was found the night of the shooting in a St. Albert home, deceased from a self-inflicted gunshot wound.

SHYMKIW, Kenneth, 46, Edmonton

On October 26, 2015, Kenneth Shymkiw became unresponsive while being transported in a police vehicle following a bail hearing.

GERMA, Dustin, 29, Edmonton

On December 24, 2017, Dustin Germa died from a self-inflicted gunshot wound following a standoff with police.

McQUEEN, David William, 53, Calgary

On January 24, 2016, David McQueen was shot during an altercation with the Calgary Police Service.

MOISAN, Marcel, 49, Edmonton

On December 8, 2015, Marcel Moisan became unresponsive following an altercation with police which included the use of a conductive energy device.

S.S.R., 17

On September 2, 2016, S.S.R. was found hanging in the basement of her residence.

J.J.S., 28 weeks

On February 12, 2015, J.J.S. was found experiencing a seizure after he had been put down for a nap on top of a blanket on an adult-sized bed. He was transported to hospital where his neurologic status did not improve and the criteria for brain death was met on February 15, 2015.

POHL, Russell Edward, 37, Red Deer

On December 25, 2015, Russell Pohl was shot by police after a pursuit which involved a front end loader.

BISSET, Cameron, 54, Edmonton

On April 9, 2013, Cameron Bisset was found unresponsive in his apartment following a welfare check.

DASNA, Father Gilbert, 32, St. Paul

QUADROS, John, 55, St. Paul

On May 9, 2014, Father Gilbert Dasna was shot and killed by John Quadros. John Quadros then took his own life during an exchange of gunfire with police.

L.S.P. 5 weeks

On May 9, 2017, L.S.P. was found unresponsive in her home.

On November 3, 2014, Private Steven Allen was injured while participating in a military exercise at Canadian Forces Base Wainwright. He was flown to hospital in Edmonton where he succumbed to his injuries on November 5, 2014.

CROFT, Jason Clark, 38, Edmonton

On May 25, 2016, Jason Croft was found unresponsive in his cell at the Edmonton Institution.

ROGG, Justin, 30, Edmonton

On August 30, 2016, Justin Rogg was found hanging in a University of Alberta building.

H.M.P., 16

On February 19, 2017, H.M.P. was found unresponsive in a hotel room. She was transported to hospital where her condition deteriorated and she died on February 23, 2017.

L.Z.H., 1

On February 23, 2016, L.Z.H. was brought to the hospital in cardiac arrest. On February 27, 2016, he died from the effects of cold exposure.

J.E.M., 4 months

On January 6, 2017, J.E.M. was found unresponsive in an adult-sized bed he was sharing with his mother.

ROGERS, Richard, 54, Pitt Meadows, BC

On September 24, 2014, Richard Rogers received a fatal chest injury when a large air conditioning unit fell on him.

HOUG, James, 19, Grande Prairie

On January 2, 2015, James Houg was fatally shot during an altercation with police.

WOODALL, Cst. Daniel, 35, Edmonton

On June 8, 2015, Cst. Daniel Woodall of the Edmonton Police Service was fatally shot in the line of duty.

BLIND, Tyrone Blue, 31, Edmonton

On January 31, 2018, Tyrone Blind was found hanging in his cell at the Edmonton Institution. He died on February 1, 2018, following withdrawal of care.

DRISCOLL, Timothy, 34, Edmonton

On December 2, 2016, Timothy Driscoll was found unresponsive in his cell at the Edmonton Remand Centre. The cause of death was later determined to be choking, and the manner suicide.

WEAFER, Lorna, 36, Edmonton

On May 7, 2014, Lorna Weafer was killed during a predatory black bear attack at Suncor worksite near Fort McMurray.

OSTERLAND, Cody Derek, 23, Drumheller

On September 21, 2016, Cody Osterland was found unresponsive in his segregated cell at the Drumheller Institution.

ROY, Jason Gary, 34, Calgary

On February 28, 2014, Jason Roy was shot multiple times following a vehicular pursuit with police.

On October 28, 2017, Jack Hamilton became unresponsive following restraint by police. He was resuscitated and transported to hospital; however, his condition did not improve and he died on November 2, 2017.

On November 28, 2013, John Clark was admitted to hospital where he died the next day from overwhelming staphylococcal septicemia due to deficiency dermatitis and malnutrition.

RADITA, Alexandru Gabriel, 15, Calgary

On May 7, 2013, Alexandru Radita died from bacterial sepsis due to complications of neglect and starvation.

HEFFERNAN, Anthony, 27, Calgary

On March 16, 2015, Anthony Heffernan was shot during an altercation with members of the Calgary Police Service.

On March 29, 2017, E.R. was found deceased in bed with her mother. The cause of death was determined to be methamphetamine toxicity.

On July 13, 2018, Maxim Baril-Blouin was found unresponsive in his bed at the Edmonton Remand Centre.

J.H., 27weeks

On May 28, 2017, J.H. was found unresponsive in his bassinet by his father.
