Updated to reflect modern monitoring technologies (e.g., passives, Relative Accuracy Test Audit (RATA), Cylinder Gas Audit (CGA), fugitives), specify required data summarization, and standardize monthly reporting requirements (rather than the use of sector specific reporting forms). Removes requirement to submit ambient data with the monthly report, as this data will be submitted electronically. Requires summarization of monthly monitoring via submission of Excel forms.
