**Re: Deciduous Pulp Dues Rates for the Period April 1, 2012 to April 30, 2012**

This letter provides notice of Crown Timber and Forest Resource Improvement Association of Alberta (FRIAA) dues for deciduous pulpwood as established in the Timber Management Regulation and the Forest Resource Improvement Regulation.
