



Alberta had the third highest percentage of immigrants in its working age population at 23.6%, behind Ontario at 33.5%, and British Columbia at 31.7% (Table 1).

Alberta's share of working age immigrants in Canada at 10.8% was the fourth highest after Ontario's 52.3%, British Columbia's 16.8% and Quebec's 14.2% (Table 2).


Immigrant working age population by province, 2017 Table 2


The number of new immigrants in Canada that came to Alberta in 2017 was 42,107 (Figure 1). This was 7,107 or 14.4% lower than in 2016. Compared to 2007, the 2017 number of new immigrants was 21,241 or 101.8% higher.

Alberta's annual share of new immigrants arriving in Canada grew continuously from 2007 to 2015, then slightly declined in 2016 and 2017 (Figure 2). For 2017, Alberta's share of Canada's new immigrants was 14.7%.

Labour Force Statistics

The 810,000 landed immigrants in Alberta made up 23.6% of the working age population in 2017, while the landed immigrant labour force of 573,300 was 23.1% of the labour force in Alberta (Table 3).


In 2017, landed immigrants in Alberta had the second highest participation rate among all provinces, at 70.8%, behind Saskatchewan's 73.0%. The Canadian rate for landed immigrants was 63.6% (Figure 3).

At 80.3%, Alberta recent immigrants had the highest participation rate among the three immigrant categories in 2017 (Figure 4). This rate was 13.5 percentage points higher than the participation rate of established immigrants and 7.9 percentage points higher than the provincial average.

The provincial participation rate for men in Alberta was higher than the corresponding rate for male landed immigrant Albertans by 0.9 percentage points (Figure 5).

Participation rates, 2017 Figure 5




Landed immigrants in Alberta had the third highest employment rate, at 64.5% behind Saskatchewan's 67.5% and Manitoba's 65.4% (Figure 6). The employment rate for immigrants in Alberta in 2017, was 5.2 percentage points above the Canadian immigrant rate of 59.3%.

Employment rates of landed immigrants by province, 2017 Figure 6




In 2017, recent immigrants in Alberta had the highest employment rate, at 73.2% (Figure 7). This rate was 12.4 percentage points higher than the rate for established immigrants. The provincial employment rate was 66.7%.

In 2017, the employment rate for Alberta landed immigrant males was 0.9 percentage points lower than provincial rate for males. The rate for female landed immigrants was 2.9 percentage points lower than the provincial rate for females (Figure 8).

Employment rates, 2017 Figure 8




The unemployment rate at 8.8% for Alberta landed immigrants was 2.1 percentage points higher than Canada's unemployment rate of 6.7% for landed immigrants (Figure 9). The unemployment rate for landed immigrants in Alberta was third highest in Canada and lower than: Newfoundland and Labrador, at 11.3%; and Prince Edward Island, at 10.0%.

Unemployment rates of landed immigrants by Province, 2017 Figure 9




The unemployment rates for landed immigrants in 2017 varied by the length of residence in the country since arrival. The unemployment rate for very recent immigrants was 0.3 percentage points lower than the rate for established immigrants (Figure 10).

In 2017, the unemployment rate for Alberta landed immigrant males was 0.1 percentage points higher than provincial rate for males. The rate for landed immigrant females was 1.9 percentage points higher than the provincial rate for females (Figure 11).

In 2017, 413,200 or 79.0% of employed Alberta landed immigrants worked in the Services-Producing Sector (Figure 12).

The top four industries in which landed immigrants were employed in 2017 were:





Together, these four industries accounted for 47.2% of all employed landed immigrants in the province.

Established immigrants, 36.5% were employed in three industries:

Occupation

In 2017, a higher proportion of Alberta landed immigrants were employed in four occupations compared to the provincial average (Table 5). These occupations were:

- · Sales and services,
- Natural and applied sciences and related,
- · Health,
- Manufacturing and utilities.

Together, these four occupations accounted for 51.5% of employed Alberta landed immigrants compared to the provincial share of 40.4%.

In 2017, the occupation that employed the highest proportion of very recent, recent and established immigrants was Sales and service (Table 6).

Full-time and Part-time Employment

Alberta landed immigrants had a lower proportion of part-time employment compared to the provincial average. Established Alberta landed immigrants had the highest percentage of full-time employment, at 83.1%; while very recent landed immigrants had the highest percentage of part-time employment among landed immigrants, 20.2%. 
Average hourly wage



Overall, landed immigrants in Alberta earned less per hour than the provincial average. The average hourly wage paid to landed immigrants was \$2.94 less than the provincial average hourly wage in 2017.

Alberta landed immigrants employed in two industries earned higher average hourly wages than the provincial industry average: Forestry, Fishing, Mining, Oil and Gas, \$2.92 higher; and Professional, Scientific and Technical Services, \$1.01 higher (Figure 13).

The provincial average hourly wage by occupation was higher than the average for Alberta landed immigrants except in Art, culture, recreation and sport occupations (Figure 14). The three occupations with the largest difference between the provincial average and the average for Alberta landed immigrants were:


- Occupations in manufacturing and utilities, at \$6.86;
- Management, at \$5.77;
- Natural resources, agriculture and related production occupations, at \$5.22.

The average hourly wages for landed immigrants increased as they became more established in Alberta (Figure 15). Established immigrants received the highest average hourly wage, which were \$7.32 more than very recent immigrants and


\$4.64 more than recent

Appendix

All of the following definitions are from the **Guide to the Labour Force Survey**, Statistics Canada.

Average Hourly Wage:

Based on hourly wage before taxes and other deductions, and include tips and commissions. Only persons who are an employee are included in the average.

Employment Rate:

The number of persons employed expressed as a percentage of working age population (WAP).

Industry:

The general nature of the business carried out by the establishment for whom the respondent works (main job only).

Labour Force:

The labour force is the portion of the civilian, non-institutional population 15 years of age and over who, during the survey reference week, were employed or unemployed. The reference week is defined as the week, usually containing the 15th day of the month, in which information is collected for the Labour Force Survey.

Participation Rate:

The total labour force expressed as a percentage of the population aged 15 years and over. This measure represents the proportion of the said population that is either employed or actively seeking employment.

Working age population:

Those persons 15+ years except persons living on Indian reserves, inmates of institutions, and full-time members of the Canadian Armed Forces.

Landed immigrant:

Refers to people who are, or have been, landed immigrants in Canada. A landed immigrant is a person who has been granted the right to live in Canada permanently by immigration authorities. Canadian citizens by birth and non-permanent residents (persons from another country who live in Canada and have a work or study permit, or are claiming refugee status, as well as family members living here with them) are not landed immigrants.

Very recent immigrants:

Are individuals who have been landed immigrants in Canada for five years or less prior to the Labour Force Survey (LFS).

Recent immigrants:

Are individuals who have been landed immigrants in Canada for more than five years but no more than 10 years prior to the LFS.

Established immigrants:

Are individuals who have been landed immigrants in Canada for more than 10 years prior to the LFS.
