EnCana FCCL Oil Sands Ltd. as Operator for FCCL Oil Sands Partnership, a business venture with ConocoPhillips, is seeking approval to expand its current Christina Lake Thermal Project (The Project). The Project is located within the Regional Municipality of Wood Buffalo and situated approximately 20 kilometres east of Conklin, Alberta in Section 16, Townships 75 and 76, Ranges 5 and 6, west of the 4th Meridian.

The Project will continue to use steam-assisted gravity drainage (SAGD) thermal technology for the recovery of bitumen within The Project's area. The Project will be designed and built to increase production from the approved production limit of 98,800 barrels of oil per day to 218,800 barrels of oil per day over the next decade, and will include expansion to current facilities, new facility construction, and multiple well pads. The following projects are not part of the current application and will be applied for separately, as appropriate: Upgrades to existing roads, pipelines to supply fuel gas, electrical power lines and diluent supply pipelines.

The Director responsible for the Environmental Assessment, has directed that an Environmental Impact Assessment Report (EIA) be prepared for this proposed project. Accordingly, EnCana has prepared a Plain Language Document and a Proposed Terms of Reference for this EIA, and through this public notice invites the public to review the Proposed Terms of Reference.
