Bargaining Update is a monthly report which provides information about the unionized workforce, primarily in Alberta.

The data in this issue are derived from 40 settlements received by the Department during the month of October 2011. These settlements covered approximately 7,767 employees, 43% of whom were in the private sector.

Approximately 407,900 Albertans are covered by union agreements. Alberta's union coverage rate is 22.92% while nationwide the union coverage rate is 30.98%.*

Unemployment in Alberta decreased from 125,500 in August 2011 to 120,300 in September 2011, with the rate decreasing to 5.4% from 5.6%. Nationally, the seasonally adjusted unemployment rate decreased from 7.3% in August 2011 to 7.1% in September 2011, with the number of unemployed persons decreasing by 33,700 to a total of 1,334,200.*

Labour Relations News from Other Jurisdictions

British Columbia

About 41,000 public school teachers, represented by the B.C. Teachers Federation (BCTF), have been restricting administrative duties since the school year began in September. They voted to do so in late June 2011 at the time their five year provincial collective was set to expire. The teachers are concerned with the slow progress in bargaining and in talks with the provincial government over an April 2011 B.C. Supreme Court ruling on Bills 27 and 28. The Supreme Court ruled that these Bills restricting bargaining on job conditions such as class size and class composition were unconstitutional. The parties (the provincial government and the BCTF) were given one year to address the matter. However, the parties disagree on the interpretation of the ruling. The BCTF asked the B.C. Supreme Court judge who made the ruling to provide clarification, but she refused to do so. Meanwhile, the employer group involved in bargaining, the B.C. Public School Employers' Association (BCPSEA), has filed an application with the B.C. Labour Relations Board that the BCTF be ordered to reimburse school districts 15 percent of salaries and benefits for the duties teachers are not performing. The application also asks that teachers be required to prepare and distribute report cards. If this were to occur, the BCPSEA has indicated they may drop the application to reduce salaries and benefits.

On the same day the application was filed, B.C. Education Minister George Abbott announced the creation of the B.C. Teachers Council, a body to replace the B.C. College of Teachers. The College was created in the 1980's to set standards, to issue teaching certificates, to investigate complaints and to impose discipline. A fact-finding report in 2010 found the College does not consistently put student safety ahead of the interests of teachers due to the degree of influence held by the BCTF. The Council will include three members of the BCTF, seven education partners chosen by government and five members elected by teachers. However, a separate disciplinary board will be created to hear complaints of a serious nature. In that body, the BCTF will not be allowed to have more than one member on any three member panel. As well, certification of teachers will now by handled by the Ministry of Education.

CUPE has a Universities Coordinated Bargaining Committee (UCBC), involving ten locals at six sites. The six are: the University of British Columbia in Vancouver; Simon Fraser University in Burnaby, Vancouver, and Surrey; the University of Victoria; Royal Roads University near Victoria; Thompson Rivers University in Kamloops; and the University of Northern B.C. in Prince George. In March 2010, eight of the ten locals served notice to bargain, and the other two followed shortly thereafter. The UCBC meets regularly to coordinate bargaining, share progress, and monitor the status of bargaining in other education sectors and involving other provincial unions. The UCBC, representing about 12,000 CUPE members, met in both September and October 2011, and set dates for future meetings in November and December 2011 and January 2012. At the October 2011 UCBC meeting, the representatives agreed to an action plan to try to move bargaining forward. This includes all locals securing new bargaining dates, and meeting with government and opposition representatives. Common issues for the UCBC locals include job security, contracting out, and wages. The coordinated approach by CUPE locals extends to other education sectors, including the K-12 Presidents Council and the CUPE Colleges Bargaining Council.

Saskatchewan

CUPE is calling for a provincial collective agreement for support staff in the school system. The CUPE Education Workers Steering Committee produced a paper in March 2011 entitled "One Collective Agreement for all Education Support Workers". CUPE is the major union representing support staff in Saskatchewan's Pre K-12 education system. CUPE represents almost 6,500 employees in 20 of the 28 school division in the province, including 15 of the 18 public school divisions and five of the ten separate school divisions. School teachers in Saskatchewan bargained provincially for wages and benefits since 1973. Local issues for teachers are bargained in each school division. Prior to 2006, CUPE had 58 collective agreements with school support staff. This was reduced to the current 26 agreements with the amalgamation of public school divisions on January 1, 2006 (two of these involve a contracted school bus company). It is the view of CUPE that one provincial agreement replacing 24 existing agreements would provide savings to school boards as a result of reduced costs of bargaining and a proposal for benefit costs to be borne by the province, rather than by the individual school divisions.

Canada

CAW, Local 1016 has reached a tentative agreement with NAV Canada. Local 1016 represents about 290 members at all the major airports in Canada and at NAV Canada's Ottawa headquarters. The members provide training and operational support to Canada's air traffic control system and aviation users. Although terms of the tentative agreement were not released, Local 1016 President Shawn Wood indicated it provides improvements for members in each year. CAW members of Local 1016 will be voting on the tentative agreement over the next few weeks across Canada.




