**Bargaining Update** is a monthly report which provides information about the unionized workforce, primarily in Alberta.

The data in this issue are derived from 54 settlements which were received by the Department during the month of May 2011. These agreements covered approximately 37,300 employees, 43% of whom were in the private sector.

Approximately 400,200 Albertans are covered by union agreements. Alberta's union coverage rate is 23.5% while nationwide the union coverage rate is 31.6%.

Unemployment in Alberta increased to 130,300 in April 2011 from 124,200 in March 2011, with the rate increasing from 5.7% to 5.9%. Nationally, the seasonally adjusted unemployment rate decreased slightly from 7.7% in March 2011 to 7.6% in April 2011, with the number of unemployed persons decreasing by 10,900 to a total of 1,424,100.

## **Highlights**

#### **Gate Gourmet and UFCW**

In the dispute between Gate Gourmet Canada Inc. (Cara Operations Limited – Edmonton) and the UFCW Local 401, strike/lockout action, which commenced on April 16, 2011, continues. Sixty seven employees are involved.

## **Calgary Handi-Bus Association**

In the dispute between the Calgary Handi-Bus Association and the Amalgamated Transit Union, Local 583, the Disputes Inquiry Board (DIB) has until June 14, 2011 to reach a settlement or issue recommendations. No strike or lockout action can occur while the DIB is in place.

## Canada Safeway Limited and UFCW

Three memorandums of agreement have been reached involving UFCW. Two are with Local 401 with 7,358 employees in the Retail group and 1,002 employees in the Meat, Delicatessen and Fish Departments in southern Alberta. The third is with UFCW Local 1118 with 850 employees in the Meat, Delicatessen and Fish Departments in northern Alberta.

### **Government of Alberta and AUPE**

A three-year collective agreement to March 31, 2013, covering about 21,580 provincial public servants has been ratified by both parties.


### Extendicare (Canada) Inc. - Michener Hill and AUPE

A Disputes Inquiry Board (DIB) was established on May 19, 2011. The DIB will have until July 18, 2011 to reach a settlement or issue recommendations.

## **Construction Industry Settlements**

The following Construction groups have settled their collective agreements in the 2011 round of bargaining.

Term of each agreement is 48 months with an expiry date of April 30, 2015, except for the Sprinkler Fitters agreement, which expires in 2013 in accordance with their national bargaining format.

There is no wage increase in the first year of the agreements. Wage increases for 2012 through to 2014 will be based on formula calculations.

## **Recent Labour Relations Developments in Other Jurisdictions**

#### Saskatchewan

The Health Sciences Association of Saskatchewan (HSAS) has engaged in strike action in four health regions over the past three weeks. The employer is the Saskatchewan Association of Health Organizations (SAHO). Due to the province's essential services legislation, a certain number of employees must continue to work during a labour dispute. Therefore, more than half of the HSAS members involved are prevented from striking. The HSAS has been pushing for the dispute to be resolved through arbitration, but this has been resisted by both SAHO and the provincial government. Negotiations between SAHO and the HSAS are continuing.

The Saskatchewan Government and General Employees Union (SGGEU) is involved in collective bargaining with the Saskatchewan Cancer Agency and is holding meetings with members and taking strike votes. The SGGEU claims that their members at the Cancer Agency are paid significantly less than counterparts in the health regions. The employees include pharmacists, dosimetrists, registered nurses, mammography tech support staff, medical radiation therapists, and system analysts. The SGGEU indicates that a government-imposed wage cap of one, two, and two per cent over three years is preventing a deal from being reached. The say their difficulty is not with the Cancer Agency, but with Premier Wall, who opposes the option of arbitration. About 12,000 school teachers, represented by the Saskatchewan Teachers' Federation staged a two-day province-wide strike May 25 and 26, 2011. The strike is in protest to the rate of progress in negotiations with an employer bargaining committee comprised of school board members and the provincial government. A similar protest strike was held on May 5, 2011. The current agreement expired August 31, 2010, and talks between the parties broke off on May 19, 2011. The teachers are asking for a 16.3 per cent increase over three years, while the province has offered 5.5 per cent over three years, with additional increases for starting teachers and those with over a decade of experience. The parties have agreed to meet with a mediator who will report back to the government if no agreement is reached by June 10, 2011.

#### **Ontario**

About 3,000 City of Hamilton inside and outside workers, represented by CUPE, Local 5167 have provided their negotiating committee with an 84 per cent strike mandate. The current agreement between the parties expired on December 31, 2010. The union considers that deals reached with other Hamilton employees have been superior to that offered, and is concerned that management sent details of their offer directly to Local 5167 members, rather than to union representatives. Conciliated (mediated) negotiations between the parties continue.

More than 600 workers at Electro-Motive in London, represented by the CAW, are in bargaining for a new collective agreement. The firm manufactures rail locomotives, and was purchased in August 2010 by the U.S. company Progressive Rail, a division of Caterpillar. The employer has set a June 1, 2011 deadline to complete negotiations and the union sees this as a lead-in to a lockout. Bargaining began on April 19, 2011, and the plant is currently on a two-week shutdown. The employer has indicated they have moved inventory and equipment off the site. The locomotive plant has operated in London since 1950.

## **Newfoundland and Labrador**


In October 2010, former Premier Danny Williams appointed a Commission of Inquiry to address the strike by Steelworkers' members at the Voisey's Bay nickel mine owned by Brazil-based Vale. The strike began in August 2009. The Commission made recommendations on this dispute which resulted in a settlement in January 2011. It also made a recommendation that the provincial Labour Relations Board have the power to impose a collective agreement to end a protracted labour dispute. The Newfoundland and Labrador Employers Council is urging the provincial government to reject the idea, believing it would drive business away from the province. The Minister of Human Resources, Labour and Employment, Darin King, said he has not decided where he stands on this recommendation. #### Canada

Target Corp. of the U.S. plans to fill 20,000 retailing jobs as it opens 100 to 150 stores across Canada beginning in 2013. They have taken on the leases of about 220 Zellers stores, but have indicated they will not be automatically taking on Zellers workers as employees. Eighteen Zellers stores are unionized nationally, mostly with the UFCW, which represents workers at twelve locations in Ontario and two in Quebec. Target is expected to announce the location of some of its stores soon, and it is not known whether any of the unionized stores will be involved. If so, issues of successorship would likely be a concern. The situation is further complicated in Quebec, as considerations of successorship apply to some degree to non-union employees. 
