


DID YOU KNOW?

RELATIONSHIP OVERVIEW

- In 2000, Minnesota was Alberta's 8th largest source of U.S. visitors.
- Tourists from Minnesota spent \$18.6 million in Alberta in 2000.
- Energy sales account for half of the state's imports from Canada, including over 90% of Alberta exports.


Alberta Exports to Minnesota



TRADE AND INVESTMENT

- Canada is Minnesota's largest export market.
 Imports from Minnesota to Canada reached \$4 billion in 2003.
- Over the past five years, Alberta exports to Minnesota have averaged \$4.2 billion per year.
- Exports included crude oil, natural gas, lumber, urea, chemical woodpulp, newsprint, and steel bars and rods.
- In 2003, imports totaled more than \$241 million.
- Main imports from Minnesota to Alberta include maize, soya bean oil, prepared foods, and writing paper.
- In 2002, Alberta exports to Minnesota increased by 48%, making the state Alberta's 3rd largest international export market, largely due to increased oil and gas commodity shipments.
