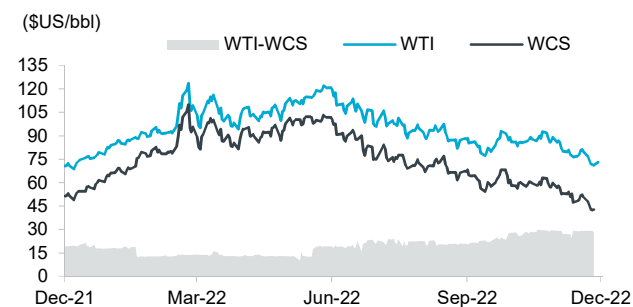
Indicators at a glance

New: Oil Prices

WTI increased \$4.65 over the week and closed at US\$76.11 on Thursday. The WTI-WCS differential closed at US\$28.00 per barrel, unchanged from a week ago.

Daily prices



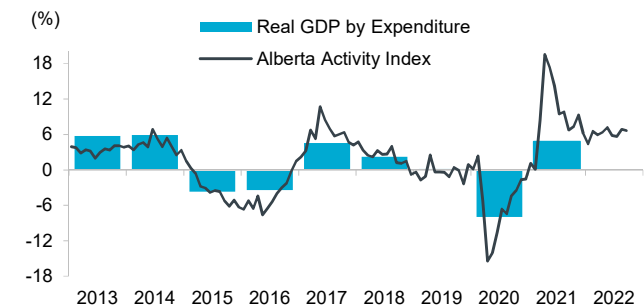

Economic Activity

The Alberta Activity Index remained essentially unchanged in September (0.01% month-over-month), but was up 6.6% from a year ago. Alberta's real GDP by expenditure increased by 4.8% in 2021, following a large decline in 2020.

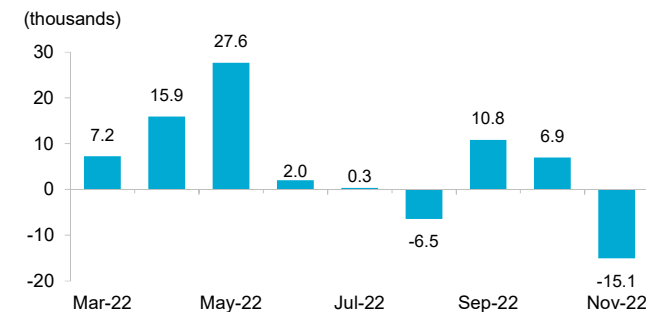
Labour Market

Employment decreased by 15,100 in November. Compared to a year ago, it was up by 82,400. The next release is on January 06, 2023.

Alberta's unemployment rate was 5.8% in November, up 0.6 percentage points from October but 1.8 percentage points below a year ago.

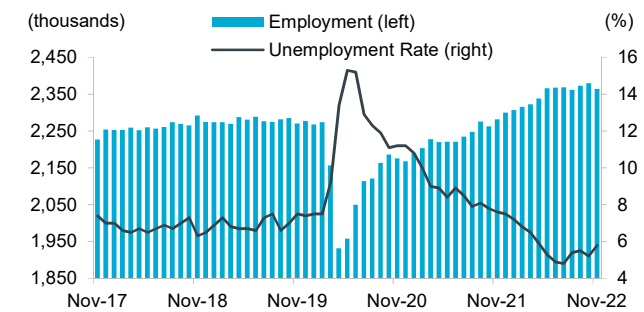
Monthly change in employment

New: Business Output

Manufacturing shipments increased 7.3% m/m to \$9.5 billion in October. Compared to a year ago, they were up 29%.

Alberta goods exports increased 1.4% m/m in October to \$17.8 billion. They were up 46% from a year ago.

Year-over-year % change



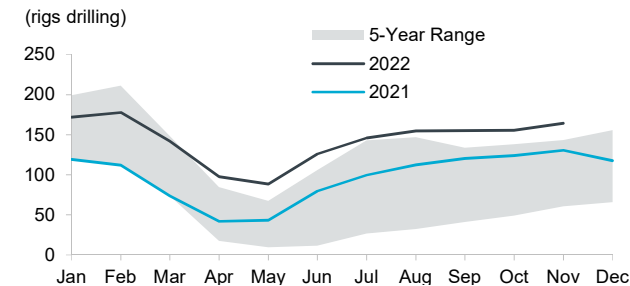

The number of rigs drilling in Alberta averaged 165 in November, up 26% from a year ago.

Average Weekly Earnings

Average weekly earnings in Alberta increased 0.6% m/m in September to \$1,266. They were up 2.6% from a year ago.

Population Growth

Alberta's population was 4,543,111 as of July 1, 2022, an increase of 2.2% from the year prior. During the last 12 months, Alberta welcomed 59,998 net international migrants and saw a net inflow of 21,660 interprovincial migrants.

Inflation

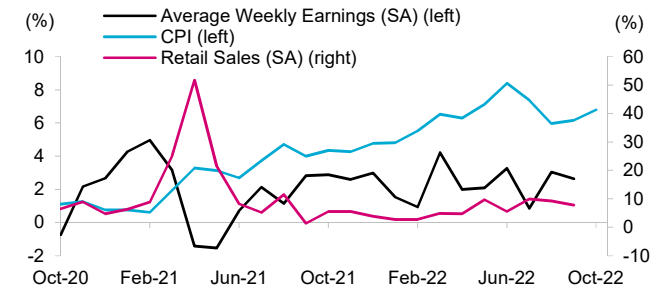
The consumer price index in Alberta increased 6.8% y/y in October, up from 6.2% y/y in September.

Retail Sales

Alberta retail sales decreased 1.6% m/m to \$7.9 billion in September. Compared to a year ago, sales were up 7.7%.

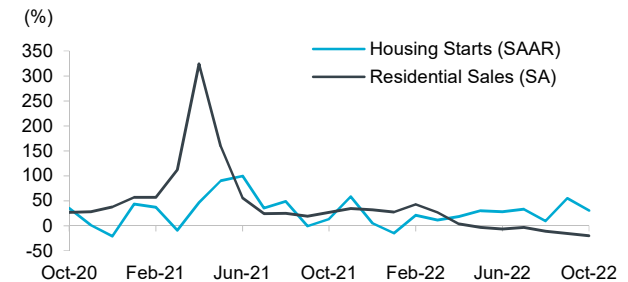
New: Housing Market

Alberta housing starts declined 34% m/m in November to 31,936 units (SAAR). They were down 24% from a year ago.

The number of home sales in the resale market went up 2.2% m/m to 5,880 units in October, and were down 20% y/y.

Year-over-year % change

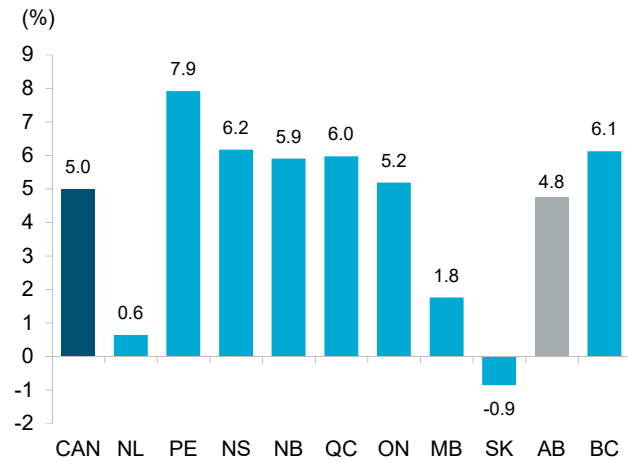

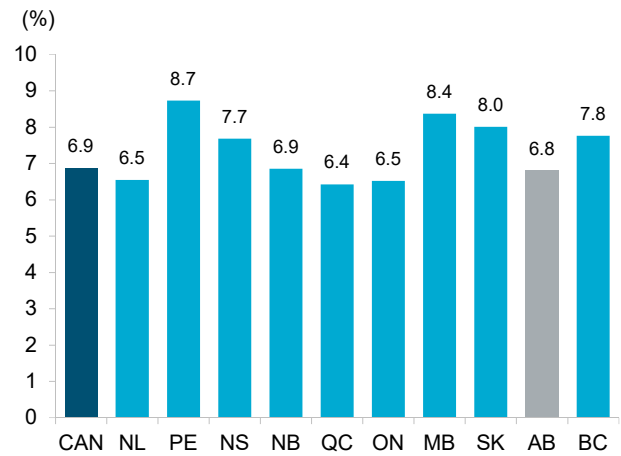
REAL GDP BY EXPENDITURE

(2021, year-over-year growth)



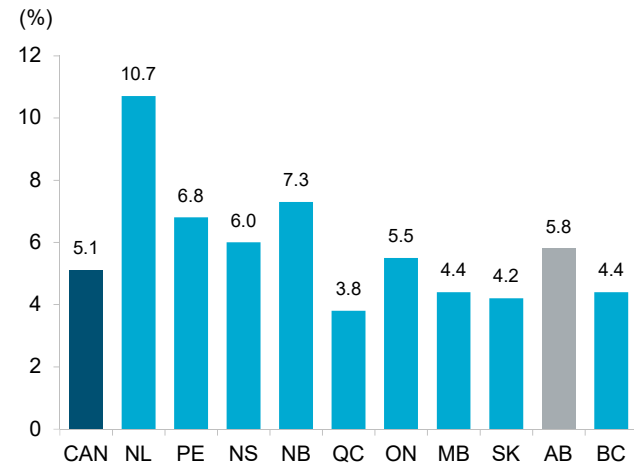
CPI INFLATION

(October 2022, year-over-year growth)



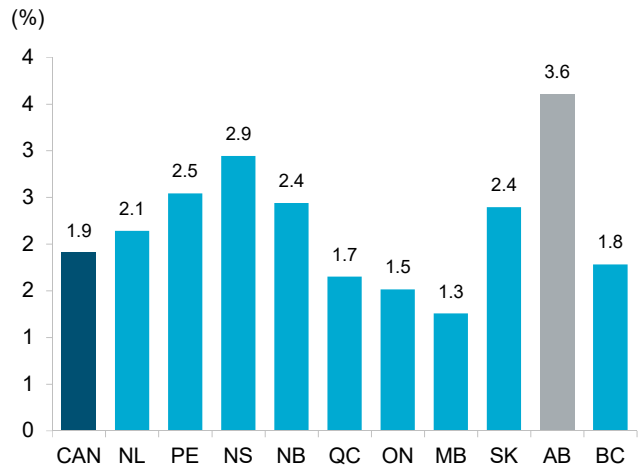
UNEMPLOYMENT RATE

(November 2022)



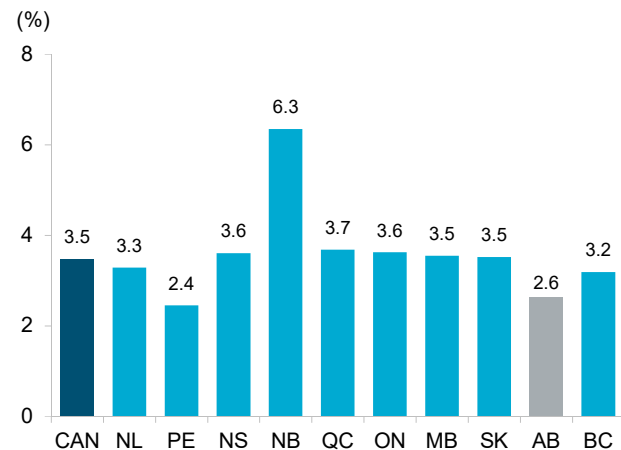
EMPLOYMENT

(November 2022, year-over-year growth)



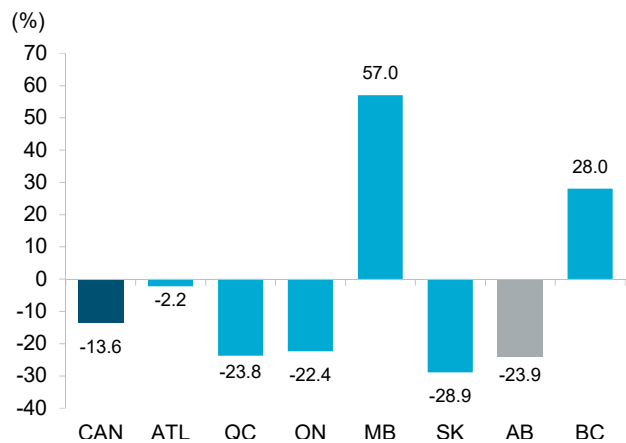
AVERAGE WEEKLY EARNINGS
