As outlined in the attached letter of decision, Cosmic Hire Limited:

- Engaged in unfair practices by giving galse, misleading or deceptive information to a consumer in contravention of s. 6 (4)(a) of the *Consumer Protection Act* and 13 (2)(b) of the Employment Agency Business Licensing Regulation.
- Failed to create and maintain records in accordance with the regulatory requirements in contravention of s. 9 of the Employment Agency Business Licensing Regulation.
- Demanded and collected prohibited fees or compensation for employment agency services in contravention of s. 13 (2)(e) of the Employment Agency Business Licensing Regulation.

As per the attached decision letter, I have assessed three administrative penalties totaling \$12,500 for the above contraventions of the *Consumer Protection Act* and Employment Agency Business Licensing Regulation.

This notice of administrative penalty to Cosmic Hire Limited has been served pursuant to section 158.1(1) of the *Consumer Protection Act* and the Administrative Penalties (*Fair Trading Act*) Regulation, AR135/2013, for the reasons set out in the attached letter of decision.

If payment has not been received in this time period, the Notice may be filed in the Court of King's Bench and enforced as a judgement of that Court pursuant to section 158.4 of the Consumer

Payment of an Administrative Penalty

Right of Appeal

- 3) the name of the appellant; and
- 4) the address for service of the appellant.

Pursuant to the section 4 of the Administrative Penalties (Fair Trading Act) Regulation, AR135/2013, the appeal fee is \$1,000.
