BRONAUGH, Michael Benjamin, 24, Edmonton

On December 11, 2011, Michael Bronaugh was shot by police during an armed bank robbery. He was transported to hospital where he died on December 12, 2011.

GOLTMAN, Lisa Rachel, 22, Edmonton

On May 4, 2013, Lisa Goltman was found unresponsive in her bed at Alberta Hospital Edmonton.

HOLTEEN, Ryan, 32, Edmonton

On September 26, 2013, Ryan Holteen was found unresponsive in his cell at the Edmonton Institution. Four other inmates have been criminally charged in relation to his death.

MATTHON, Shane, 31, Edmonton

On March 7, 2015, Shane Matthon was found collapsed at the Fort Saskatchewan Correctional Centre where he was serving a conditional sentence on weekends.

OLENYK, Timothy James, 18, Cochrane

On July 10, 2015, Timothy Olenyk died after jumping from a parking garage.

WITVOET, Ryan William, 31, Edmonton

On August 20, 2015, Ryan Witvoet was found in asystolic arrest in the Edmonton Institution. He was transported to hospital where it he was pronounced dead.

SINCLAIR, Jason, 29, Edmonton

On September 27, 2015, Jason Sinclair was involved in an altercation with his cellmate at the Edmonton Remand Centre. He was restrained and taken to a decontamination area where he went into medical distress. Resuscitative efforts began and he was transported to hospital where his condition deteriorated and he was pronounced dead on September 29, 2015.

ROACH, Patricia, 54, Edmonton

GEARHART, John, 37, Edmonton

On October 24, 2015, Patricia Roach was found restrained and deceased in her home.

On October 22, 2015, John Gearhart took his own life by driving in front of a moving locomotive.

SIMON, Cheryl Wendy, 42, Red Deer

On April 11, 2014, Cheryl Simon was arrested by the Hobbema RCMP and put in a holding cell. She was found unresponsive early the next morning. Resuscitation was started and she was transported to hospital where she died on April 15, 2014.

SCHOCK, Chantel Leanne, 35, Edmonton

On March 9, 2016, Chantel Schock was found unresponsive in the emergency department of the Misericordia Hospital.

WYNN, Cst. David Matthew, 42, St. Albert

REHN, Shawn Maxwell, 34, Spruce Grove

In the early morning hours of January 17, 2015, Cst. David Wynn of the RCMP was investigating a stolen vehicle when he identified Shawn Rehn as a suspect. Cst. Wynn received a gunshot wound from Rehn and died in hospital on January 21, 2015.

Shawn Rehn was found the night of the shooting in a St. Albert home, deceased from a self-inflicted gunshot wound.

SHYMKIW. Kenneth. 46. Edmonton

On October 26, 2015, Kenneth Shymkiw became unresponsive while being transported in a police vehicle following a bail hearing.

On September 28, 2012, John Walker was working on a portable trailer structure when he was fatally electrocuted.

SOMMERS, Ryan Daniel, 33, Calgary

On October 31, 2014, Ryan Sommers was shot during an altercation with members of the Calgary Police Service.

JOYAL, Britni Randal, 27, Calgary

On April 2, 2016, Britni Joyal was witnessed by members of the Calgary Police Service and the Royal Canadian Mounted Police to take her own life.

NELSON, Sean, 34, Edmonton

On August 18, 2016, Sean Nelson became unresponsive following a struggle with police. Resuscitation efforts were started and he was transported to hospital where he was pronounced deceased.

SZYBUNKA, Klayten, 37, Edmonton

The afternoon of June 28, 2014, Klayten Szybunka was found deceased in a fenced off area in downtown Edmonton. He had been issued a ticket for public intoxication and released by police earlier in the afternoon near that same site.
