**GOLTMAN**, Lisa Rachel, 22, Edmonton  
On May 4, 2013, Lisa Goltman was found unresponsive in her bed at Alberta Hospital Edmonton.

**HOLTEEN**, Ryan, 32, Edmonton  
On September 26, 2013, Ryan Holteen was found unresponsive in his cell at the Edmonton Institution. Four other inmates have been criminally charged in relation to his death.

**MATTHON**, Shane, 31, Edmonton  
On March 7, 2015, Shane Matthon was found collapsed at the Fort Saskatchewan Correctional Centre where he was serving a conditional sentence on weekends.

**SINCLAIR**, Jason, 29, Edmonton  
On September 27, 2015, Jason Sinclair was involved in an altercation with his cellmate at the Edmonton Remand Centre. He was restrained and taken to a decontamination area where he went into medical distress. Resuscitative efforts began and he was transported to hospital where his condition deteriorated and he was pronounced dead on September 29, 2015.

**SIMON**, Cheryl Wendy, 42, Red Deer  
On April 11, 2014, Cheryl Simon was arrested by the Hobbema RCMP and put in a holding cell. She was found unresponsive early the next morning. Resuscitation was started and she was transported to hospital where she died on April 15, 2014.

**SCHOCK**, Chantel Leanne, 35, Edmonton  
On March 9, 2016, Chantel Schock was found unresponsive in the emergency department of the Misericordia Hospital.

**SHYMKIW**, Kenneth, 46, Edmonton  
On October 26, 2015, Kenneth Shymkiw became unresponsive while being transported in a police vehicle following a bail hearing.

**MOISAN**, Marcel, 49, Edmonton  
On December 8, 2015, Marcel Moisan became unresponsive following an altercation with police which included the use of a conductive energy device.

**SAVIN**, Vitaly, 55, Edmonton  
On March 9, 2017, 55-year-old Vitaly Savin was fatally shot during an altercation with an Edmonton Police officer.

**LEPINE**, Adrian, 63, Edmonton  
On February 23, 2017, Adrian Lepine was found hanging in the basement of his home.

**JOHNSEN**, Morley, 59, Edmonton  
On February 16, 2018, Morley Johnsen died at the Grey Nuns hospital following a struggle with Peace Officers.

**EISEL**, Trevor Clinton, 33, Stony Plain  
On December 25, 2017, Trevor Eisel took his own life following a prolonged standoff with police.

**T.D.M.**, 17  
On March 9, 2017, T.D.M. was found unresponsive in a truck by a passerby. He was pronounced deceased at the scene.

**T.C.M.**, 16  
On June 11, 2017, T.C.M. was found unconscious in his room. Despite attempts at resuscitation he was pronounced dead in hospital.

On August 22, 2017, T.M.B. was found unresponsive. She was resuscitated and transported to hospital but died on August 24, 2017.

**HOUG, James, 19, Grande Prairie**

On January 2, 2015, James Houg was fatally shot during an altercation with police.

On February 23, 2016, L.Z.H. was brought to the hospital in cardiac arrest. On February 27, 2016, he died from the effects of cold exposure.

**R.R.P., 16**

On February 7, 2018, R.R.P. became unresponsive at her home and could not be resuscitated.

On May 26, 2017, Wenhuan Xu died in hospital from complications of hanging.

On November 12, 2017, Dennis Bishop was found unresponsive in his bed at a long term care facility.
