WHEREAS Enforcement Order No. PLA-EO-2019/03-PR (the "EO") was issued to Boyd Warner and Bathurst Inlet Developments (1984) Ltd (the "Parties") on October 4, 2019;

WHEREAS the Parties appealed the EO on October 28, 2019 (the "Appeal");

WHEREAS the Parties and Alberta Environment and Parks ("AEP") met on January 30, 2020 for a mediation session as a part of the Appeal process, resulting in an agreement to:

- Change the date for the Parties to submit a plan to remediate the unauthorized activity to April 1, 2020 (the "Remedial Plan");
- Change the date for the Parties to complete the work in the Remedial Plan to November 1, 2020;

WHEREAS the Director agrees that the mediated changes to the timelines are reasonable;

WHEREAS the Director is of the opinion that PLA-EO-2019/03-PR must be amended to reflect the new timelines;

THEREFORE, I, Owen Cook, the Director, pursuant to section 59.1 of the *Public Lands Act*, DO HEREBY ORDER THAT:

- 1) In Clause 2 of PLA-EO-2019/03-PR, "December 1, 2019" is replaced with "April 1, 2020";
- 2) In Clauses 3(vi) and 5 of PLA-EO-2019/03-PR, "August 1, 2019" is replaced with "November 1, 2020".

Notwithstanding the above requirements, the Parties shall obtain all other necessary approvals from any other regulatory agency (federal or provincial) in complying with this order.

Take notice that this enforcement order is a remedial tool only, and in no way precludes any enforcement proceedings being taken regarding this matter under the Act or any other legislation. Failure to comply with the terms and conditions of this enforcement order may result in enforcement proceedings.

Section 211 of the *Public Lands Administration Regulation* may provide a right of appeal against this decision to the Public Lands Appeal Board. There may be a strict time limit for filing such an appeal.
