<b>Area:</b>	12,404 acres (5,019.7 hectares)

<b>Responsible Association:</b>	Jack Pine Grazing Association Looks after livestock and maintains the developed pastures in good, productive condition. Maintains all fence lines, dugouts, corrals and the buildings at the headquarters site. Provides bulls for breeding program.
<b>Grazing Season:</b>	Mid-May to mid-October
<b>Cattle:</b>	Approximately 7,500 Animal Unit Months (AUMs)
<b>Minimum number of Patrons:</b>	33 patrons

Within the reserve, there are 6,956 acres (2,815 hectares) that have been developed into tame pasture. A small area on the south side of the reserve has been reserved from any development, due to the wetness of the area. Adjacent to this area is a peat moss operation that harvests peat from the large peat bogs that are typical in this area.

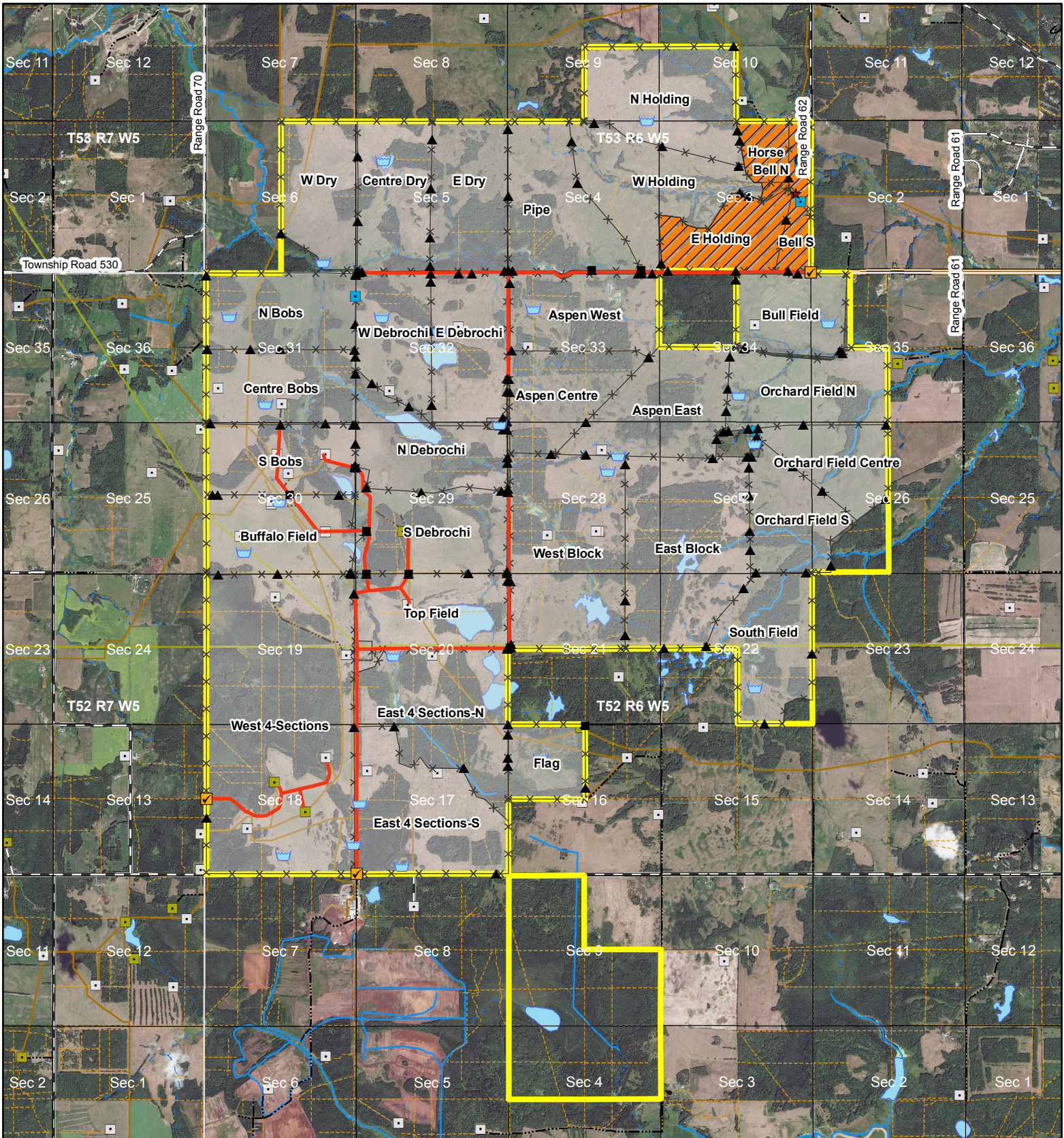
The reserve has been looked at as a possible landfill site due to its location close to Highway No.16 and its large size. Fortunately, soil tests have shown that the subsoil isn't adequate to be used for a landfill.
