

Alberta Seniors, Community and Social Services Open Data Assured Income for the Severely Handicapped (AISH)

Program Overview

The Assured Income for the Severely Handicapped (AISH) program provides financial and health related benefits to adult Albertans with severe and permanent disabilities that substantially limits their ability to earn a livelihood.

AISH provides a monthly living allowance, a child benefit, health benefits, and personal benefits (in the form of extra monthly or one-time expenses), to assist clients with their living needs and to live as independently as possible. In determining an individual's eligibility for AISH benefits, consideration is given to the applicant, client and their cohabiting partner's income and assets.

AISH open data was first published in October 2018 and is presented as a portion of the entire Alberta population. The data describes the actual average caseload volume each month as well as by fiscal year. The data is updated in the third week of the month and includes the following measures:

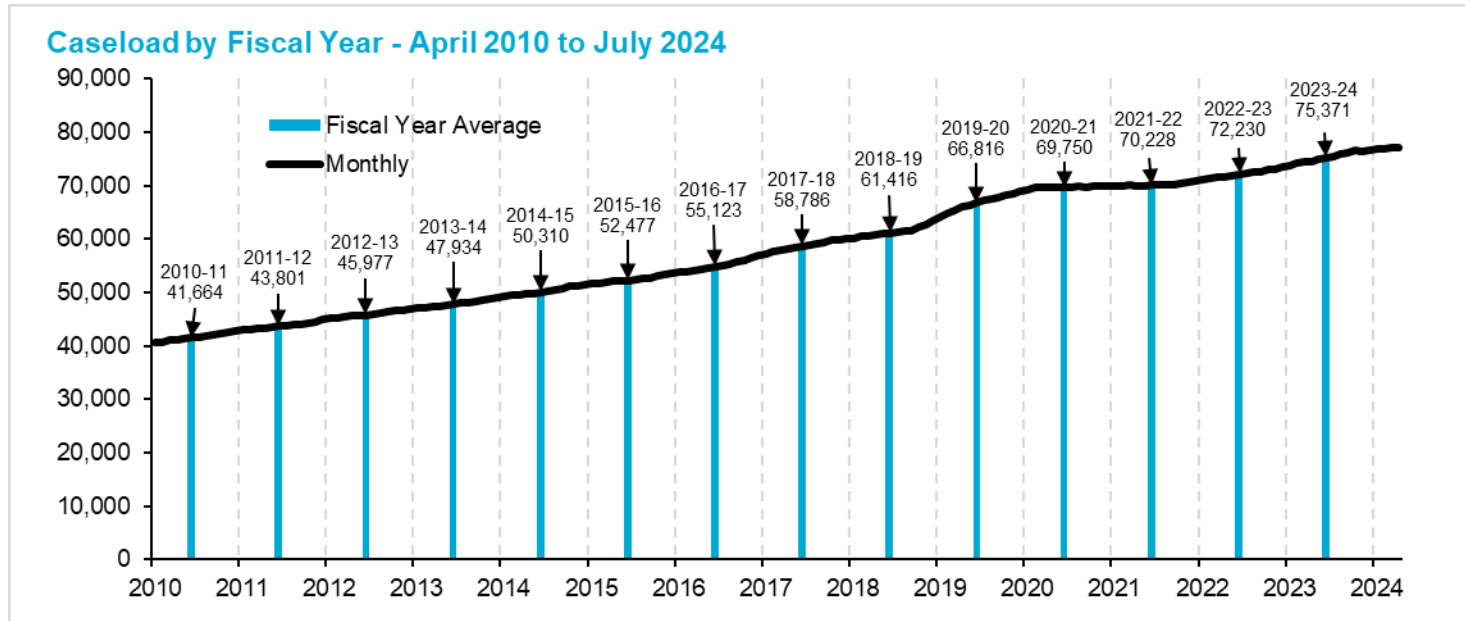

The total AISH caseload for July 2024 was 77,154; an increase of 0.16% from the previous month.

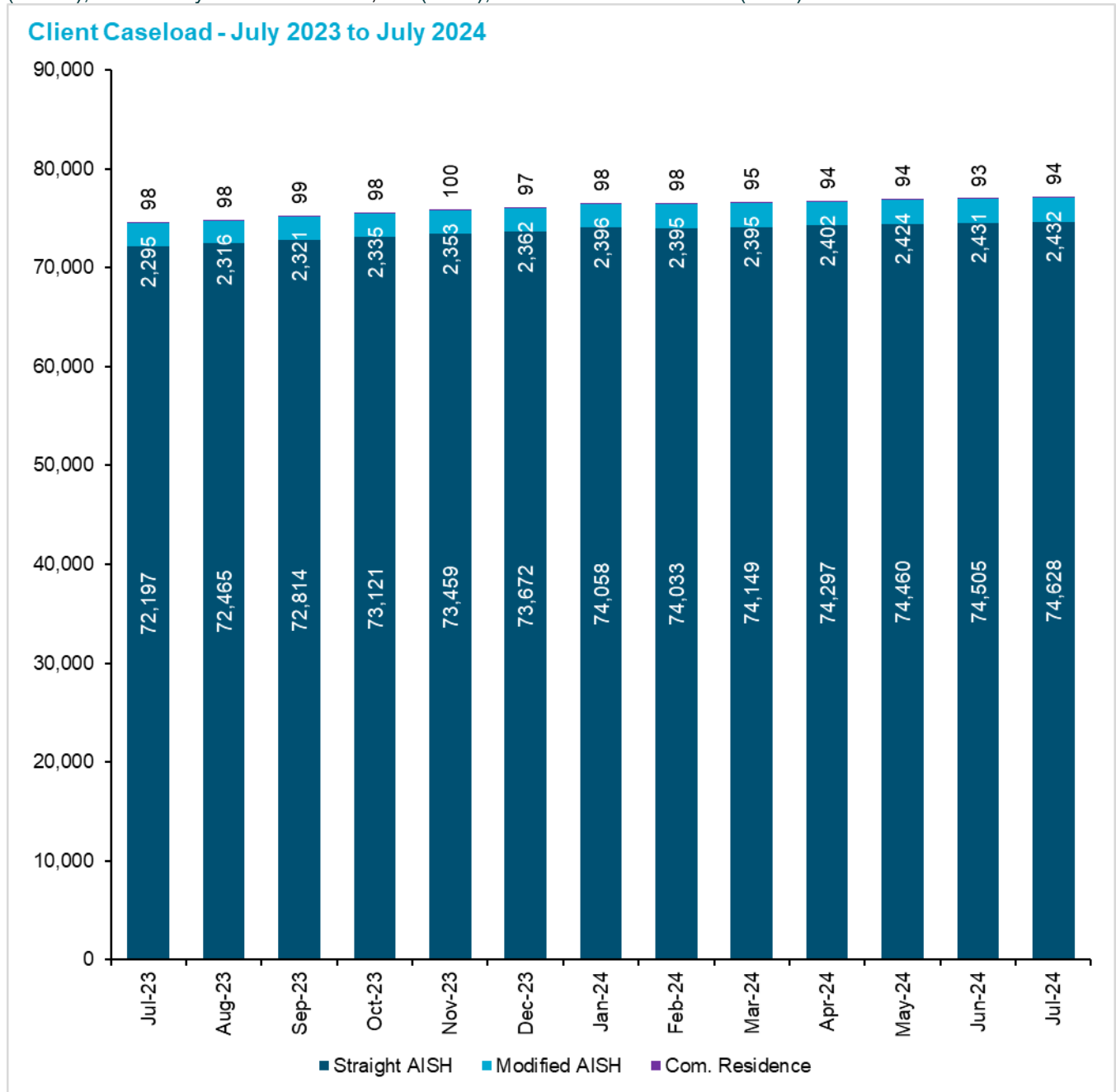
- From July 2023 to July 2024, the total AISH caseload showed an increase of 3.4%.

Client Caseload - July 2023 to July 2024 [\[back to top\]](#)

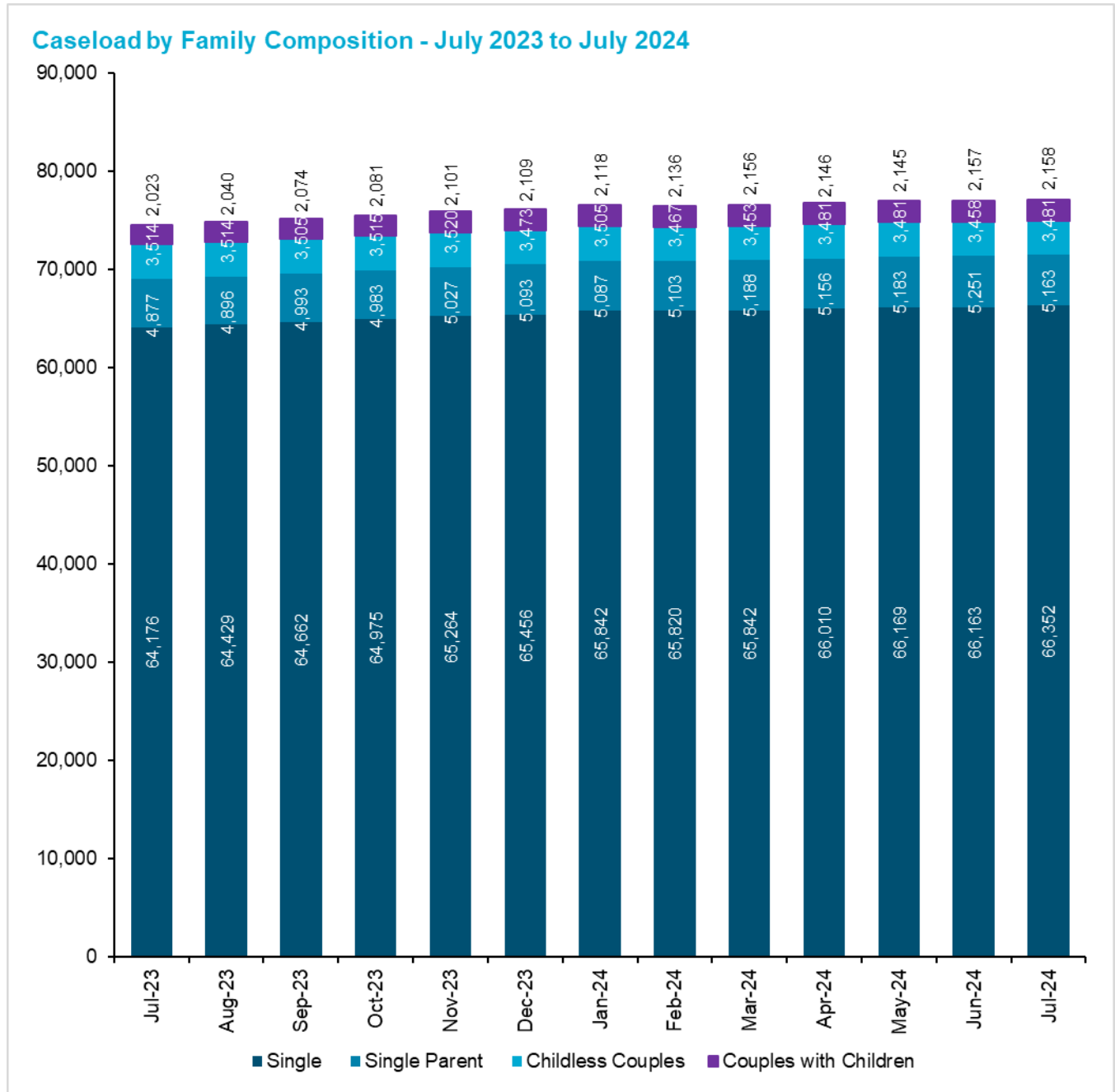
The total client caseload of 77,154 for July 2024 showed the highest proportion to be Straight AISH 74,628 (96.7%), followed by Modified AISH 2,432 (3.2%), and Com. Residence 94 (0.1%).

The total caseload of 77,154 for July 2024 includes single individuals 66,352 (86.0%), single parents 5,163 (6.7%), childless couples 3,481 (4.5%), and couples with children 2,158 (2.8%).

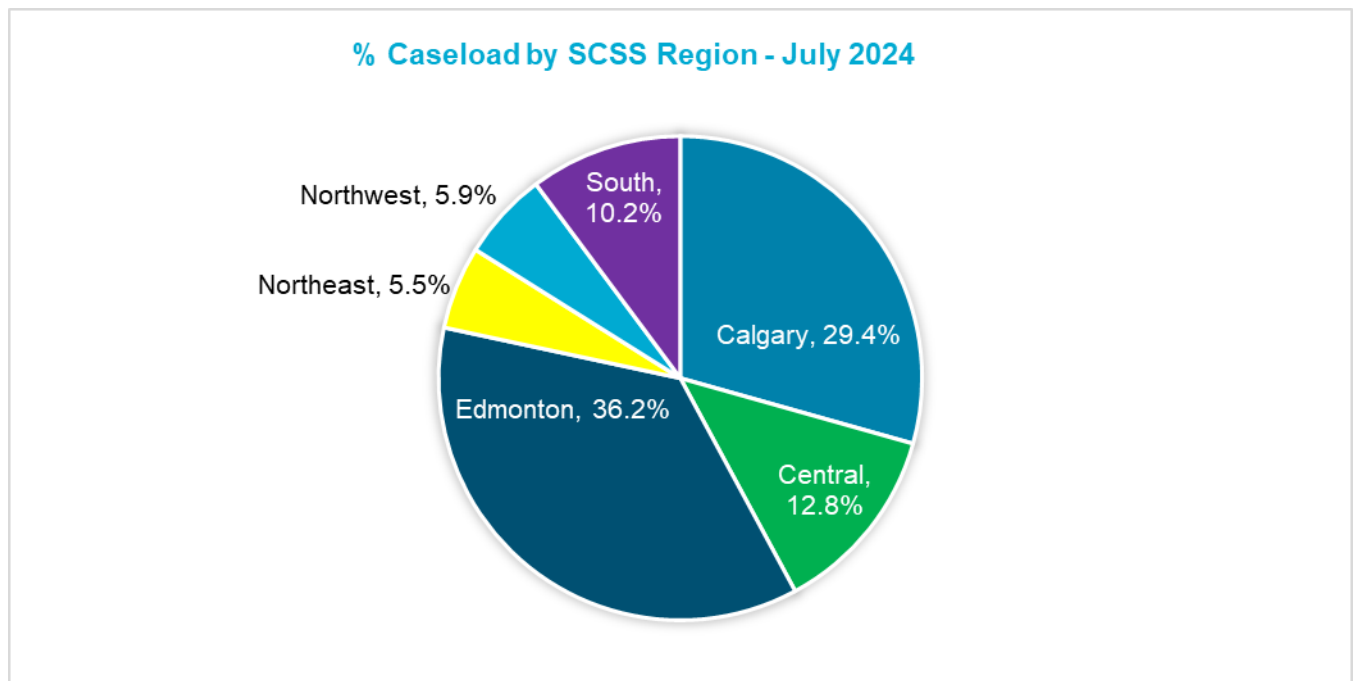
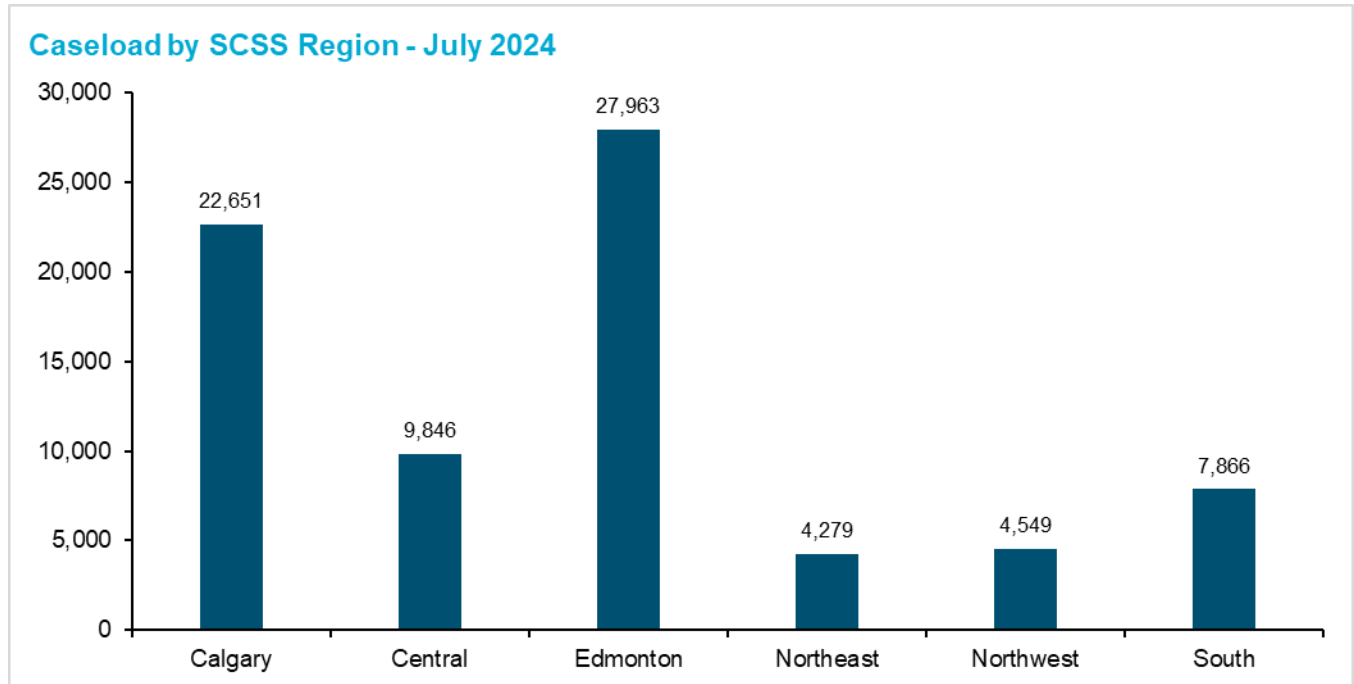

Regional data for July 2024 showed Edmonton as having the highest proportion of caseloads: 27,963 (36.2%), followed by Calgary: 22,651 (29.4%), Central: 9,846 (12.8%), South: 7,866 (10.2%), Northwest: 4,549 (5.9%), and Northeast: 4,279 (5.5%).





Proportion Caseload by Age Group - July 2024 [\[back to top\]](#)

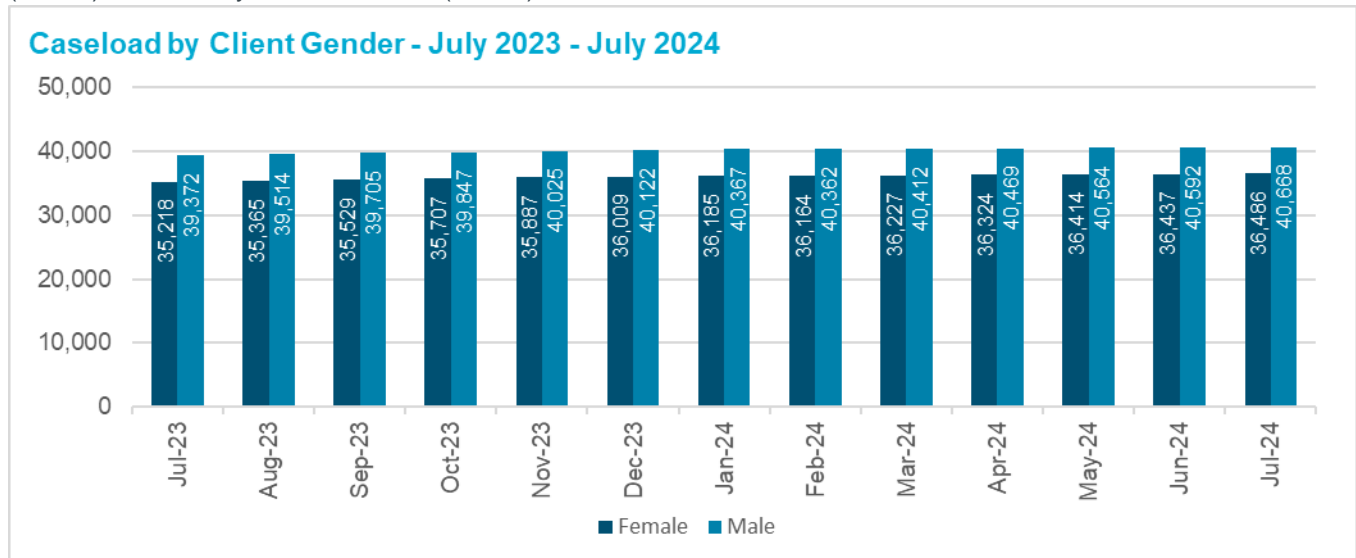
Caseload by Age Group for July 2024 showed the highest proportion from a total of 77,154 AISH clients were aged 55-59 years (12.9%), 50-54 years (10.2%), 25-29 years (10.2%), and 30-34 years (10.1%).

Client Gender for July 2024 showed the higher proportion, from a total of 77,154 AISH clients, to be Male 40,668 (52.7%), followed by Female 36,486 (47.3%).

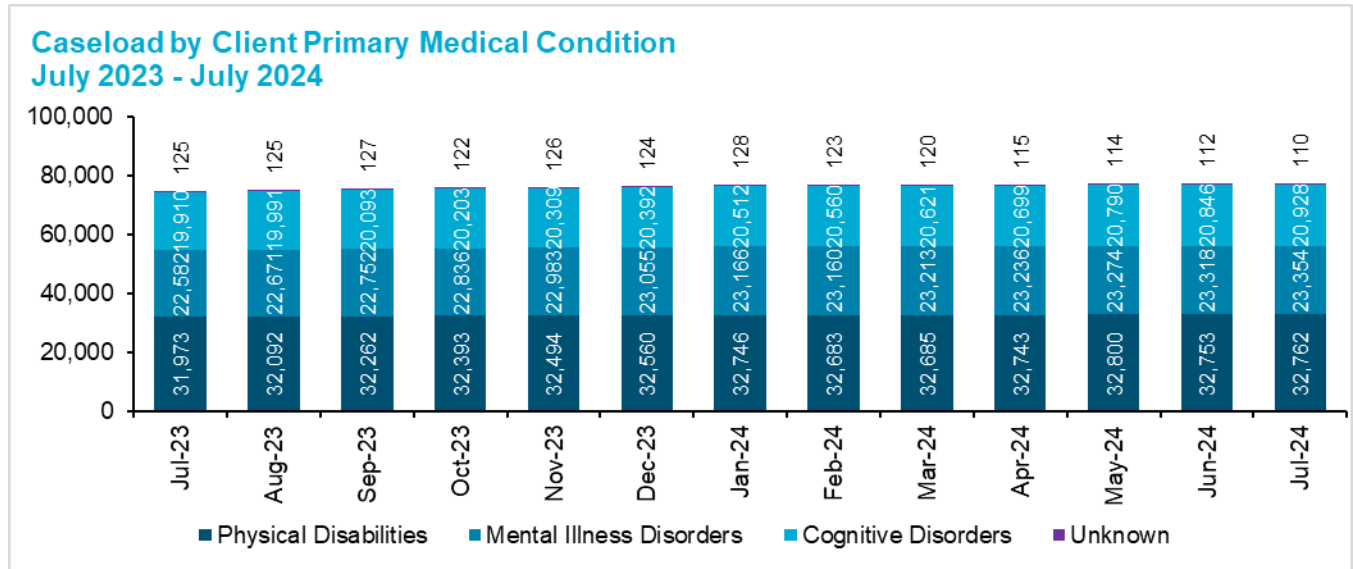

Caseload by Primary Medical Condition - July 2023 to July 2024 [back to top](#)

Caseload by Primary Medical Condition for July 2024 showed the highest proportion of 77,154 AISH clients to be related to Physical Disabilities 32,762 (42.5%), followed by Mental Illness Disorders 23,354 (30.3%), Cognitive Disorders 20,928 (27.1%), and *Unknown 110 (0.1%).

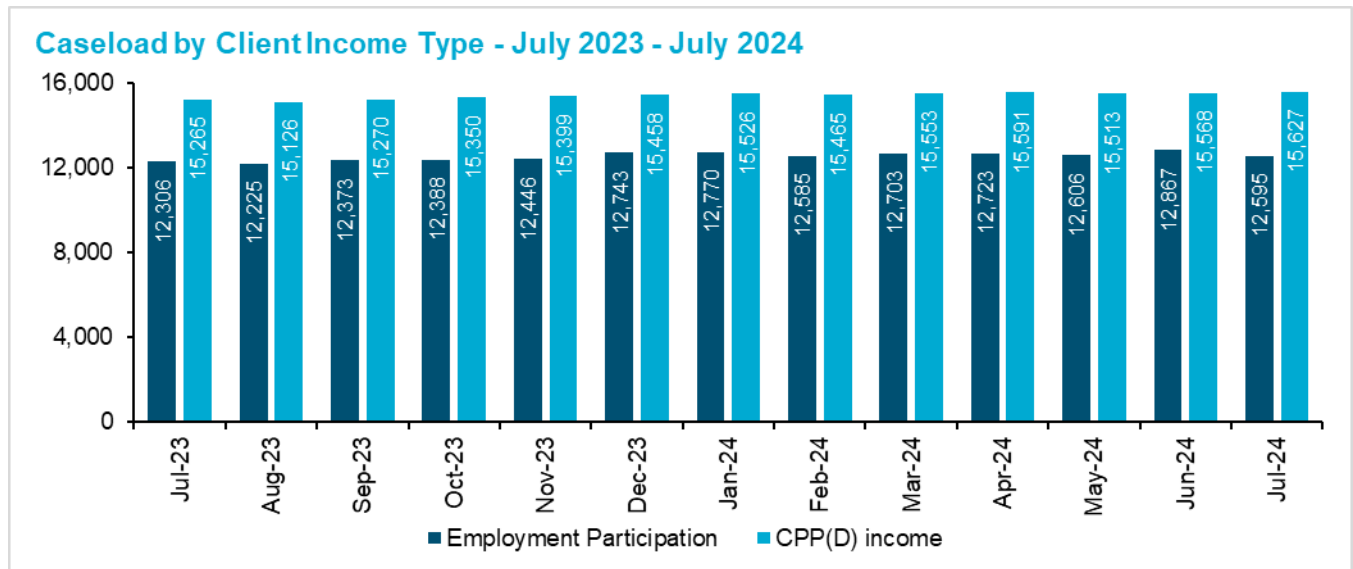

Caseload by Client Income Type for July 2024 showed the total number of clients with CPP(D) income to be 15,627 (20.3%), and the total number of all types of Employment and Self-Employment incomes for client and/or partner (Employment Participation) to be 12,595 (16.3%).
