ENFORCEMENT ORDER NO. EO-EPEA-38541

AMENDMENT NO. 3

Richardson Oilseed Limited 2415 – A Ave N Lethbridge, AB T1H 6P5 ["Richardson"]

WHEREAS Enforcement Order No. EO-EPEA-38541 (the "Order") was issued to Richardson on July 29, 2022;

WHEREAS on October 28, 2022, Amendment No.1 of the Order was issued, requiring an implementation date of January 31, 2023 for the Ambient Air Monitoring Plan;

WHEREAS on January 31, 2023, Amendment No. 2 of the Order was issued, extending the implementation date to April 30, 2023 for the Ambient Air Monitoring Plan;

WHEREAS Clause 17(b) of the Order, as amended, requires Richardson to submit monthly reports containing validated data collected since the previous monthly report.

WHEREAS this monthly deadline for submission of validated data from the immediately preceding month frequently does not allow adequate time for the required compilation and validation to be completed.

WHEREAS the Director is of the opinion that it is appropriate to amend the due dates for submission of the validated monthly data, which amendment will also align with the requirements of Alberta's Air Monitoring Directive (Government of Alberta, December 2016, as amended);

WHEREAS section 212(1) of the *Environmental Protection and Enhancement Act* provides authority for the Director to amend an Enforcement Order;

WHEREAS Coreen Bates, Compliance Manager, Southern Region, has been appointed as a Director [the "Director"] for the purposes of issuing and amending Enforcement Orders under the Act; **THEREFORE**, I, Coreen Bates, the Director, pursuant to section 212(1) of the *Environmental Protection and Enhancement Act*, DO HEREBY AMEND the Order as follows:

18. Deleting Clause 17(b) of the Order, as amended, and replacing it with:

17(b) a monthly report of all monitoring results with validated data, in accordance with the following schedule:

(i) on November 30, 2023, for all validated data collected in the calendar month of October 2023; and

(ii) every month thereafter, by the end of the month following the month of data collection.
