

ENVIRONMENTAL PROTECTION AND ENHANCEMENT ACT BEING CHAPTER E-12 R.S.A. 2000 (the "Act") ENFORCEMENT ORDER NO. EO-EPEA-38541 AMENDMENT NO. 1

Richardson Oilseed Limited 2415 –A Ave N Lethbridge, AB T1H 6P5 ["Richardson"]

WHEREAS Enforcement Order No.EO-EPEA-38541 (the "Order") was issued to Richardson on July 29, 2022;

WHEREAS Richardson submitted an Ambient Air Monitoring Plan on August 31, 2022;

WHEREAS Clause 7(g) of the Order requires a commencement date of not later than October 31, 2022 for the Ambient Air Monitoring Plan;

WHEREAS on October 26, 2022 Richardson submitted a revised Ambient Air Monitoring Plan and requested an extension to the implementation date for the Ambient Air Monitoring Plan to March 1, 2023 to address delays in equipment procurement;

WHEREAS section 212(1) of the *Environmental Protection and Enhancement Act* provides authority for the Director to amend an enforcement order;

WHEREAS Coreen Bates, Compliance Manager, Southern Region, has been appointed as a Director [the "Director"] for the purposes of issuing and amending Enforcement Orders under the Act;

WHEREAS the Director has reviewed and considered the request to extend the implementation date for the Ambient Air Monitoring Plan and is of the view that an extended implementation date of the Ambient Air Monitoring Plan to January 31, 2023 is appropriate;

THEREFORE, I, Coreen Bates, the Director, pursuant to section 212(1) of the *Environmental Protection and Enhancement Act*, DO HEREBY AMEND the Order as follows:

- 10. Richardson shall, no later than January 31, 2023, implement each subsection of sections:
 - (a) 2. Monitoring Location;
 - (b) 3. Parameters and Equipment;
 - (c) 4. Quality Assurance and Control; of the October 6, 2022 Ambient Air Monitoring Plan.
- 11. Richardson shall, from January 31, 2023 and continuously until otherwise directed in writing by the Director carry out each part of the October 6, 2022 Ambient Air Monitoring Plan.
- 12. Immediately upon implementation of the Ambient Air Monitoring Plan, and until otherwise authorized in writing by the Director, Richardson shall submit each of the following in writing to the Director:
 - (a) on February 7, 2023, and each Tuesday thereafter, a weekly report of all monitoring results collected since the previous weekly report as described in section 5 of the October 6, 2022 Ambient Air Monitoring Plan; and
 - (b) on March 7, 2023, and the first Tuesday of each month thereafter, a monthly report of all monitoring results with validated data collected since the previous monthly report, as described in section 5 of October 6, 2022 Ambient Air Monitoring Plan.
- 13. In Clause 9 of the Order, deleting the words "Approval No. 00000281-09-00" and replacing them with "Approval No. 00000281-03-00".
