## **ENFORCEMENT ORDER NO. EO-EPEA-38541**

## AMENDMENT NO. 2

Richardson Oilseed Limited 2415 – A Ave N Lethbridge, AB T1H 6P5 ["Richardson"]

WHEREAS Enforcement Order No.EO-EPEA-38541 (the "Order") was issued to Richardson on July 29, 2022;

WHEREAS on October 28, 2022, Amendment No.1 of the Order was issued, requiring an implementation date of January 31, 2023 for the Ambient Air Monitoring Plan;

WHEREAS on January 26, 2023, Richardson requested that the implementation date be extended due to delays in equipment procurement;

WHEREAS the Director is of the opinion that, to address the delays, an extension of the Ambient Air Monitoring Plan implementation date to April 30, 2023 is appropriate;

WHEREAS section 212(1) of the *Environmental Protection and Enhancement Act* provides authority for the Director to amend an Enforcement Order;

WHEREAS Coreen Bates, Compliance Manager, Southern Region, has been appointed as a Director [the "Director"] for the purposes of issuing and amending Enforcement Orders under the Act;

**THEREFORE**, I, Coreen Bates, the Director, pursuant to section 212(1) of the *Environmental Protection and Enhancement Act*, DO HEREBY AMEND the Order as follows:

- 14. Deleting Clauses 10, 11 and 12 of the Order.
- 15. Richardson shall, no later than April 30, 2023, implement each subsection of sections:

(a) 2. Monitoring Location;
(b) 3. Parameters and Equipment;
(c) 4. Quality Assurance and Control;
of the October 6, 2022 Ambient Air Monitoring Plan.

- 16. Richardson shall, from April 30, 2023 and continuously until otherwise directed in writing by the Director carry out each part of the October 6, 2022 Ambient Air Monitoring Plan.
- 17. Immediately upon implementation of the Ambient Air Monitoring Plan, and until otherwise authorized in writing by the Director, Richardson shall submit each of the following in writing to the Director:
  - (a) on the earlier of May 2, 2023 or the first Tuesday following the implementation of the Ambient Air Monitoring Plan, and each Tuesday thereafter, a weekly report of all monitoring results collected since the previous weekly report as described in section 5 of the October 6, 2022 Ambient Air Monitoring Plan; and
  - (b) on May 2, 2023, and the first Tuesday of each month thereafter, a monthly report of all monitoring results with validated data collected since the previous monthly report, as described in section 5 of October 6, 2022 Ambient Air Monitoring Plan.
