## Completed Fatality Inquiries – Waiting For Report

Updated April 3, 2024

**ROGG**, Justin, 30, Edmonton

On August 30, 2016, Justin Rogg was found hanging in a University of Alberta building.

**E.R.**

On March 29, 2017, E.R. was found deceased in bed with her mother. The cause of death was determined to be methamphetamine toxicity.

**POUCETTE**, Cavin Kelsy, 26, Morley

On October 19, 2017, Cavin Poucette was shot during an altercation with the Royal Canadian Mounted Police.

**E.S.**

On April 18, 2020, E.S. was found hanging in a basement.

**T.M.**, 19

On December 19, 2017, T.M. was found hanging in a wooded area east of Maskwacis.

**C.J.L.**

On December 19, 2017, C.J.L. was found hanging in her home.

**S.R.**

On May 30, 2017, S.R. was found hanging in her home. She was resuscitated and transported to hospital but died on May 31, 2017.

**ANDERSON**, Jonathan Wayne, 40, Edmonton

On March 5, 2020, Jonathan Anderson was found hanging in his cell at the Edmonton Remand Centre. He was resuscitated and transferred to hospital where his condition deteriorated and he died on March 14, 2020.

**ISFELD**, Glenn, 51, Gunn

On February 9, 2016, Glenn Isfeld was found unresponsive in the McCullough Centre.

**PELLETIER**, Andre Martin, 60, Calgary

On May 22, 2019, 60-year-old Andre Martin Pelletier found unresponsive while in care at the Peter Lougheed Centre for psychiatric treatment.

**L.M.B.**

On November 13, 2018, L.M.B. was found hanging in a barricaded room. L.M.B. had a history of previous suicide attempts.

**HAGUE**, Timothy, 34, Edmonton

On June 18, 2017, 34-year-old Timothy Hague died in hospital. Two days prior, he was competing in a professional boxing match.

On January 7, 2017, Ralph Stephens was shot during an altercation with police.

**FENTON**, Jesslyn Marie, 25, Galahad

On November 2, 2018, Jesslyn Fenton was found deceased in her home.

**J.R.A.**

On July 2, 2015, J.R.A. was found unresponsive hanging from a wooden structure.

**T.D.S.**

On September 25, 2014, T.D.S. was pronounced deceased after he was found unconscious by his mother in their home on September 18, 2014. On February 6, 2017, his mother pleaded guilty to manslaughter.

**S.T.**

On October 12, 2017, S.T. was found unresponsive in bed.

**EVERT**, Alyssa Blanche, 33, Edmonton

On June 15, 2018, Alyssa Blanche Evert was found unresponsive in her bunk at the Edmonton Remand Centre.

**MUDRYK**, Peter, 30, Edmonton

On November 29, 2017, Peter Mudryk was found unresponsive in his cell at the Edmonton Remand Centre.

**JACKSON**, Ross Rodney, 33, Calgary

On June 25, 2018, a passerby found Ross Rodney Jackson unresponsive and trapped inside a clothing donation bin. He was admitted to hospital and died on June 27, 2018.

**O`QUINN**, Jessey Neil, 24, Calgary

On July 20, 2017, Jessey Neil O`Quinn was trapped inside a clothing donation bin, and died.

**MEYER**, Amara Rose, 41, Medicine Hat

On May 27, 2019, Amara Rose Meyer was trapped inside a clothing donation bin, and died.

**McCLENNON**, Edward, 53, Edmonton

On June 5, 2021, Edward McClennon was admitted to hospital from remand jail with possible opioid withdrawal symptoms. He died on June 8, 2021 after suffering a seizure.

**NORRIS**, Terrence, 68, Edmonton

On September 15, 2020, 68-year-old Terrence Norris died in hospital after an ECT treatment.

On August 29, 2017, 47-year-old Eric Labreque was found unresponsive in his cell at the Calgary Remand Centre. The cause of death was determined to be accidental carfentanyl and fentanyl toxicity.

On July 13, 2018, Maxim Baril-Blouin was found unresponsive in his bed at the Edmonton Remand Centre.

**WHITFORD**, Frank Frances, 19, NFA

On November 9, 2019, Frank Frances Whitford was found unresponsive in police holding cells after being arrested for public intoxication. He was transported to hospital where he died the following day from multi-system organ failure.

---

On December 15, 2020, Frederick snow died in hospital. Two days earlier, he was found unresponsive in his cell at the Calgary Remand Centre.

On June 2, 2019, Andrew Edy's body was found floating near a dry dock in Glenmore Reservoir. He had been missing for several months prior.

---

**BOOMHOWER**, Martin David, 56, Wainwright

On June 9, 2021, Martin Boomhower was involved in a high speed motor vehicle accident. He died on June 17, 2021 from the injuries suffered in the collision.

---

**FIRST CHARGER**, Kevin Rex, 50, Blood Tribe Reserve

On February 5, 2015, Kevin First Charger was taken into RCMP custody for his own safety and placed in a cell. On February 6, 2015, in the early morning, he could not be awakened. Emergency services attended, but he died.

---

**DENIKE**, Susan Martha, 72, Calgary

On December 9, 2020, Susan Denike was involved in a motor vehicle collision. She was taken to hospital with significant injuries. She died in hospital on December 14, 2020.

---

**ANDERSON**, Sianna Leigh Sheila Keogh, 25, NFA

On January 4, 2021, Sianna Anderson was being moved from one room to an observation room at the Peter Lougheed Hospital. She became agitated when hospital personnel attempted to move her from the bed and a struggle ensued. She became unresponsive. CPR was performed, but she died.

On October 25, 2019, Deborah Onwu was reportedly assaulted, and died of multiple stab wounds.

---

**CLARK**, Season, 44, Calgary

On September 28, 2021, Season Clark was found deceased in her secured residence after using pharmaceutical drugs intravenously.

---

**H.A.P.**

On May 21, 2021, H.A.P. died from his injuries from being struck by another motorcycle that were sustained several days earlier.

---

**T.B.**

T.B. was found hanging in a hospital emergency room. He died 9 days later on November 29, 2021.

---

**DIXON**, Ruth, 47, Eden Valley

On June 8, 2018, Ruth Dixon was found deceased in bed at a friend's residence.

---

**RIDER**, Robynn Elizabeth Martha, 28, Calgary

On October 8, 2019, Robynn Rider, was found unresponsive in a parking lot. She was taken to hospital, but resuscitative efforts were unsuccessful.

---

**ROLLINMUD**, Durwin Dudley, 40, Eden Valley

On October 5, 2018, Durwin Dudley Rollinmud was found deceased in a bathroom.

---

**CHINQUAY**, Alvin Clifford, 40

On September 9, 2016, Alvin Chiquay was fatally assaulted in the Calgary Remand Centre. He never regained consciousness and died on September 22, 2016.

---

**PERRY**, Stacey Lynn, 30, Salmon Arm

On December 24, 2018, Stacey Perry was shot during an altercation with police.

---

**GOOD DAGGER**, Radford James, 48, Lethbridge

On October 3, 2018, Radford James Good Dagger was involved in an altercation with police. He later died on October 8, 2018.

---

**CRAWFORD**, Clayton, 31, Whitecourt

On July 3, 2018, Clayton Crawford was shot during an altercation with Royal Canadian Mounted Police members.

---

On August 2, 2021, Rebecca Elizabeth Irma Gustafson committed was found hanging in her hospital room. Resuscitation efforts were unsuccessful.

On April 5, 2022, James Albin Hanson was found unresponsive on the floor in his hospital room. Resuscitation efforts were unsuccessful.

---

**J.H.**

On June 10, 2022, J.H. was found wedged in bed at a crisis shelter. He died despite medical intervention.

**HILDEBRAND**, Daniel Robert James, 40, NFA

On July 3, 2021, Daniel Robert James Hildebrand died in hospital. He became unresponsive while in a police cruiser a few days earlier.

On January 11, 2022, D.S.J.J. was found dead in his bed with a gunshot wound.
