Product list updates: Large and small bathing and toileting equipment

Alberta Aids to Daily Living (AADL) is updating [Approved Product List B – Small Bathing and Toileting Equipment](#) and [Approved Product List G – Large Bathing and Toileting Equipment](#) to reflect manufacturer changes, price updates and product availability.

AADL has also updated the way that benefit type, authorization type and product category are described in both approved product lists to better align with how they are displayed and referenced on the Alberta Blue Cross online health portal.

In addition to these changes, AADL has updated the bed depot order form with a new email address, and adjusted the pricing model for the extra-large Rifton Pacer pediatric walker.

These updates take effect on April 12, 2024.

New catalogue numbers for heavy-duty options

Heavy-duty options for several commodes have been added, with separate prices. Previous catalogue numbers for heavy-duty options have been changed to include “HD” and are now grouped with related products. For example, G036 (Wheeled commode – Heavy-duty) has been changed to G043HD to group it with G043 (Wheeled commode – Standard).

- AADL catalogue number G014HD1 – Wheeled commode, tilt, heavy-duty 1 (up to 350 lbs.). AADL maximum price: \$2,495.
- G014HD2 – Wheeled commode, tilt, heavy duty 2 (350 to 450 lbs.). AADL maximum price: \$2,695.
- G043HD (previously G036) – Wheeled commode, standard, attendant propelled, heavy duty. AADL maximum price: \$1,380.
- G045HD – Wheeled commode, self-care or folding, heavy-duty. AADL maximum price: \$2,175.
- G067HD – Wheeled shower commode, tilt, heavy duty. AADL maximum price: \$2,950.
- G068HD – Wheeled shower commode, self-care, heavy-duty. AADL maximum price: \$2,550.
- G069HD (previously G065) – Wheeled shower commode, standard, attendant propelled, heavy duty. AADL maximum price: \$2,100.

A tilt wheeled shower commode for clients with complex needs has been added to the approved product list (G070). This option can accommodate accessories for clients who require additional support.

Pediatric walker update

The pricing model for the extra-large Rifton Pacer pediatric walker (K279-XL) has been streamlined. The maximum price for the product has been set to \$8,000 and the benefit no longer requires prior approval from AADL. Costs that exceed the maximum price will be the client's responsibility to pay.
