The Health Care and Social Assistance industry¹ in Alberta includes establishments and services such as:

- hospitals, nursing and residential care facilities and out-patient care centres;
- offices of health practitioners (i.e. dentists, doctors, optometrists and chiropractors);
- medical and diagnostic laboratories;
- home health care services;
- ambulance services;
- social assistance services (i.e. for children, youth, the elderly, families);
- community food, housing, emergency and relief services;
- vocational rehabilitation services; and
- daycare services.

2. Industry's Growth

- The Health Care and Social Assistance industry accounted for 12.0% of total employment in Alberta in 2017.
- Employment in is this industry expected to grow at an average rate of 2.7% from 2017 to 2021⁴.
- The industry is expected to account for 12.3% of total employment in Alberta in 2018.

3. Facts, Trends and Outlook

According to the latest data from Statistics Canada's National Economic Accounts, the Health Care and Social Assistance industry accounted for approximately 5.1% of Alberta's Gross Domestic Product in 2016, up from 4.3% in 2006. Its contribution to Alberta's total employment increased from 9.6% in 2007 to 12.0% in 2017.

Total employment (the total number of employees and self-employed people, 15 years and over) in 2017 was 1.7% higher than its level in 2016. Over the last 10 years, employment increased by 83,800 from 2007, a 30.6% increase. There were 274,100 employed in the industry in 2017, of whom 74.9% were full time and 25.1% were part time.

2. Demographics: Gender and Age

According to the Labour Force Survey, the gender breakdown in the Health Care and Social Assistance industry in 2017 was as follows:

- women employed: 225,100 people, or 82.1%
- men employed: 49,000 people, or 17.9%

Overall in Alberta, women accounted for 45.5% and men made up 54.6% of total employment (for all industries).


